Limpopo records lowest 2022 matric pass rate

Limpopo Province records once again the lowest matric pass rate among all the nine provinces in the country, scoring 72.1%, which is a slight improvement from the 66.7% achieved in 2021. Despite the fact that the class of 2022 is a cohort of learners who battled challenges such as Covid-19 hard lockdown and power cuts due to load-shedding, Limpopo Province saw a 5.4% improvement in the 2022 NSC results. This was revealed by MEC for Education Department in Limpopo, Mavhungu Lerule-Ramakhanya, during the matric results announcement held at The Ranch Hotel in Polokwane on Friday 20 January. A total of 111 618 learners registered for the National Senior Certificate (NSC) examinations as full-time candidates in the province, while 110 295 sat for the October/November 2022 NSC examinations. The province saw a total of 19 733 distinctions obtained by the class of 2022 as compared to 17 751 in 2021. Regarding the bachelor passes, the class of 2022 obtained 32 878 bachelor passes compared to 28 075 bachelors accounted for in 2021. The best performing district in the province was Mogalakwena with 78.3%, followed by Waterberg with 77.5%, Capricorn South and Mopani Wes tied on the third with 76.7%, Capricorn North was on the fifth position with 75.8% and Vhembe East was on the sixth position with 72.3%. Vhembe West followed on the seventh position with 70.8%, Mopani East sitting on eighth position with 68.4%, Sekhukhune South occupied the ninth position with 66.8% while Sekhukhune East was in the bottom with 64.5%. “We acknowledge that both Sekhukhune South and Sekhukhune East performed below 60% in 2021. In 2022, they have outdone themselves and have achieved above 60%. However, Sekhukhune South is now performing, while Sekhukhune East is just below the radar of performance,” said Lerule-Ramakhanya. The MEC said the performance criteria was based on overall pass rate of 65% and above and achieved 30% in a combination of bachelor and diploma passes. “We congratulate Mogalakwena, our new top performing district, we have been through a lot, we learned a lot, but we remained resilient as the province despite all the challenges we encountered. It is only resilience that was able to lift us from below 70 percent as we marched to the desired heights, the resilience that we were encouraged to master as we navigate through

the worst of times,” she said. Lerule-Ramakhanya indicated that the class of 2022 had the highest number of matric learners in the history of the exams that they have administered as a province. “Our learners have made us proud, they have given us hope and demonstrated that the sky is indeed the limit,” she said.

Elias Motsoaledi Mayor involved in car crash

The Mayor of Elias Motsoaledi Local municipality, Cllr David Tladi, sustained minor injuries after an accident that occurred in the early hours on Saturday 14 January at Tafelkop Village along the R574 Road. The accident involved the mayor's BMW X5 and a Toyota Quantum minibus taxi. According to Simon Makua, Elias Motsoaledi Local Municipality Spokesperson, the mayor was on his way to a funeral in Mogaung Village when the accident occurred. Makua confirmed that there were no fatalities during the accident, however, Mayor Tladi, his bodyguard and three other occupants sustained injuries and were rushed to Groblersdal Hospital for medical observation. Makua said more information on how the incident occurred will be communicated in due course after investigations. He said the local municipality wishes all those who involved in the accident a speedy recovery.

Overcrowded Maila Nkokonono Secondary

Parents of children attending Maila Nkokonono Secondary School in Magakadimeng Village, Moutse, say they are concerned about a serious shortage of classrooms and teachers, facing the school since 2008. According to parents, for the past fifteen years they have been approaching the Limpopo Department of Education about a dire need of extra classrooms for the school without any success. In October 2022, angry parents, joined by concerned community members, temporarily suspended classes in Maila Nkokonono Secondary. They were demanding an immediate intervention from the Education Department to resolve overcrowding and shortage of teachers in the school. Department of Education Regional Director in Sekhukhune South, TG Nkadimeng, attended to the school and promised to resolve the problem within a period of two weeks, through the allocation of two mobile classrooms from Nala Secondary school in the neighbouring Ntwane Village. However, the mobile classrooms never arrived at the school. A concerned parent, Ellah Mashiloane, told the paper that the overpopulated school is currently having six classrooms, accommodating pupils from grade eight to grade 11. "Our main problem is that the learners are doing three different subjects streams and crammed in one classroom, making it difficult for the teachers to attend to them. Other classes are overcrowded with more than 60 learners. This disrupts lessons, we want learners to be separated according to their streams of subjects so that it could be easier for them to concentrate when taking lessons from their teachers," she said. Mashiloane said a number of parents' meetings were convened since the schools reopening day without the problem being addressed. She said parents consider suspending classes until the mobile classrooms are delivered and the issue of shortage of teachers is resolved. Director Nkadimeng said he is aware of the need for mobile classrooms in the school due to overcrowding. "We identified two mobile classrooms at Nala Secondary School. We are now busy processing documents for head office to approve a service provider to collect them," he said. Nkadimeng indicated that provision of additional classrooms is determined by the Department of Infrastructure Sub-Directorate not just a demand from communities. Limpopo Department of Education Spokesperson, Mike Maringa, said the department was not aware of the situation and will investigate.

Unavailability of scholar transport leaves vulnerable pupils stranded

Dozens of learners in various parts of Sekhukhune are still left stranded on the streets after scholar transport contracted with the government fail to collect them every morning. The learners are left stranded every morning leaving parents with unanswered questions as they claim nothing is communicated to them about the issue of failing scholar transport. One of the affected areas in Ntwane in Dennilton, Moutse, where young children full in school uniform are seen roaming during school hours. Seun Mogotji, Bolsheviks of South Africa (BPSA) leader, said they have made enquiries with the department after noticing that the scholar transport is not collecting learners in the villages. "We were told that plans were afoot to make sure scholar transport is available in Moutse but sadly learners are still walking to school," he said. Mogotji said the affected learners were those residing at Dithabaneng in Ntwane where parents are urged to walk their children to Tagane Primary School. "These are young children and parents fear for their safety which is a genuine concern given the challenges of rape, kidnappings and serial killers," he said. Mogotji indicated that some motorists have seized this opportunity to take the children to school at a charge of R15 per trip, which some of the parents could not afford to pay. "Some official from the Department of Education said a service provider is still busy moving his fleet of buses to Moutse and they still have to learn the routes as they are not familiar with the area. My question is why did they appoint a service provider from outside Sekhukhune asked Mogotji. Mogotji insisted that a service provider from Sekhukhune should have been appointed from the beginning to rid of depriving children a right to education. "Surely there are people from Sekhukhune with buses and taxis who could have been hired but typical Limpopo

style, they had to bring someone from outside and now we are sitting with this problem which could have been avoided," he said. Mogotji has called on the MEC for Education in the province Mavhungu Lerule-Ramakhanya to sympathise with the children and fast track the allocation of scholar transport in the area. Mike Maringa, Limpopo Department of Education Spokesperson, said they have noted with concern shortage of scholar transport in other regions of the province. "This is due to a delay in the collection of appointment letters by recently appointed service providers. The department will ensure that all remaining appointed service providers finalize their contracts to ensure that learners are in school on time," he said.

MEC commits road upgrade after a shut-down protest

Following a week long total shut-down protest staged at various villages in Ward 12 of Ephraim Mogale Local Municipality, MEC for Public Works, Roads and Infrastructure in Limpopo, Nkakareng Rakgoale, has on Tuesday 17 January, paid a visit to the area to address community members and restore calm in the area. The protest started on 11 January by angry residents from nine villages who were complaining about lack of roads. During the demonstrations, the community barricaded all access roads including the busy R579 Road that links Groblersdal and Jane Furse. The angry communities were demanding the immediate upgrade of the D4328 Road that connects the area of the affected villages from the R579 Road. Schools and local businesses were affected during the unrest. A community leader, Kali Maelane, said they were outraged because government is failing to consider their concerns about poor state of roads in the villages. "We started to raise our complaints about the state of the road since 2010. Nothing is happening, the government is making empty promises all these years without any of them being materialized. We are demonstrating because we are tired," he said. Maelane added that they are concerned about their safety because the ambulances and the police cannot respond to their emergencies because of the poor condition of the road. "The situation is worse now because even taxi drivers

Poor state of R25 Road remains an eyesore for Moutse residents

Residents of Dennilton in Moutse say they are concerned about poor state of the R25 Road, which they claim has been an eyesore for many years. According to the community, the road is full of potholes everywhere and started to be narrowing as it is not maintained. The R25 is a major road linking Limpopo, Mpumalanga and Gauteng Provinces and used by both heavy and light vehicles. Ali Maloba, Economic Freedom Fighters (EFF) Chairperson in Sekhukhune Region and also Chairperson of Moutse Residents Committee (MRC), said for the past ten year they have been complaining to Roads Agency Limpopo (RAL) and the Office of the MEC for Public Works, Roads and Infrastructure without the ugly sights of the road being resolved. "The road has already claimed many lives. A number of letters were sent to RAL and Public Works Department where we urgently requested their intervention in order to save lives. Unfortunately the authorities seems to be not interested to our pleas," he said. Maloba said it is disappointing that the road has been expanded and upgraded into a two-way lane in each opposite direction in Mpumalanga and Gauteng, however, the upgrading and development had never taken place on the Limpopo side. "Only the Limpopo part was left narrowed, in bad condition and totally neglected. This is a clear indication that Limpopo Government, under the leadership of Premier Stanley Mathabatha does not care about safety of road users," he said. Maloba indicated that on several occasions, traffic authorities from Limpopo Provincial Government and RAL have collected data and conducted researches on the road, promising an upgrade which was never materialized. Maloba vowed that residents will resort in shutting-down the road and all traffic centres in Elias Motsoaledi Local Municipality if they do not get government urgent intervention. Bolsheviks Party of South Africa (BPSA) Leader, Seun Mogotji, said he had also written letters to Premier Mathabatha and Department of Public Works MEC, seeking their immediate intervention to better the poor condition of the road. RAL Spokesperson, Luyanda Sithole, said the agency will be commenting soon after gathering all relevant information regarding the state of the road.

refuse to drive on the road and drop residents many kilometres away from their homes. We want the government to do something about the state of the road with immediate effects," he said. Addressing hundreds of community members at Mabitsi Village, MEC Rakgoale committed that a consultant was appointed in December last year and has already started detailing designs for the road. "The standard design process takes between eight to ten months with the detailed design report as the last stage of the process," she said. The road earmarked for the upgrade stretches over 14kms, and connects four villages which are, Mmotwaneng, Vaalbank, Mabitsi and Serithing. "We are going to work tirelessly to make sure that what we have committed here today indeed is going to materialize so that the community is not returning to the streets," she said. Rakgoale commended the community of Mabitsi for not destroying any government property during the unrests and he discouraged the communities from blocking children from going to school during the demonstrations. Roads Agency Limpopo (RAL) Spokesperson, said the road in the agencies' first priority list for Ephraim Mogale and in their medium term plan to be attended very soon. Secretary of Ephraim Mogale Ward 12 Development Forum, Tumisho Phatlane, said they were delighted that the MEC interacted with the communities and the stalemate has been resolved. "We are partially happy that the MEC has promised to give us report of the appointment of the consultant that is going to make designs of our roads. They also promised us that we are going to be part of the process, working together with the consultant. We hope that the information we received here is going to happen as they promised," he said.

Police make a breakthrough in Dennilton businessman's murder

Following a massive manhunt after the murder of a Dennilton businessman, Doctor Matea, which occurred on Christmas Eve in 2020, the police have recently arrested a suspect. According to the police, the 37-year-old suspect, Thabo Kleinboy Magae, was arrested in Soshanguve Township near Pretoria by a team of investigators attached to the Limpopo Provincial Organized Crime Unit earlier this

month. Matea (46), was abducted from his home at Ntwane Village, Dennilton, in the early hours of the morning. His lifeless body was found abandoned with gunshot wounds a few hours later. Before he was murdered, Mateta was a sub-contractor in the then ongoing Moutse Drought Relief Projects, aiming for the provision of drinkable water in Moutse Villages. Stanley Ramaila, who was the Executive Mayor of

Sekhukhune District Municipality (SDM) at the time, called for the arrests and prosecution of Matea's murderers. Motlafela Mojapelo, Limpopo Provincial Police Spokesperson, said the suspect appeared before the Moutse Magistrate's Court on Monday 9 January 2023, facing charges of house robbery, kidnapping and murder. "Matea and his family were asleep in their house in the early hours of Thursday 24 December 2020 at Ntwane Village under Dennilton policing area when three men, allegedly entered their home. They demanded cash and in the process, ransacked the house and took undisclosed amount of cash and jewellery," said Mojapelo. He added that the suspects then tied up the victim's wife and three children and thereafter forced him to his Toyota bakkie and drove away with him, where later his body was found with bullet wounds in the area at 06:00 that morning. The vehicle was later found abandoned at Tambo View, a few kilometres from Matea's home. "The suspect appeared before the Moutse Magistrate's Court for house robbery and murder and was remanded in custody. He will be appearing again soon for formal bail application," he said. Provincial Commissioner of the Police in Limpopo, Lieutenant General Thembi Hadebe, has commended the team for arresting the suspect and urged community members to continue assisting the police in the fight against crime. The Mayor of Elias Motsoaledi Local Municipality (EMLM) Cllr David Tladi, applauded police for the arrest of the suspect. Tladi commended the sterling work done by the dedicated Springfield Police members worked with other law enforcement agencies in removing the murder suspect off the streets and out of the communities.

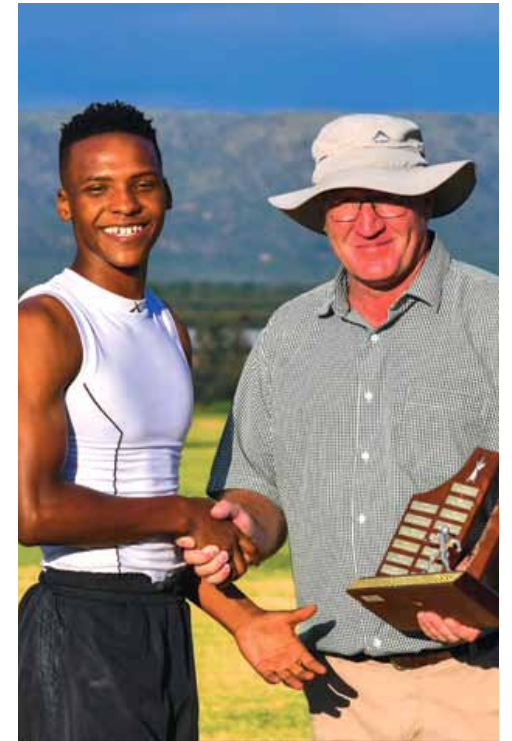
