

#### **BPSA** councillor attacked during ANC peaceful march

In what was supposed to be a peaceful march, a Bolsheviks Party of South Africa (BPSA) PR Councillor in Elias Motsoaledi Local Municipality (EMLM), Herbert Radingwana, was allegedly attacked by ANC protestors who were marching to hand-over a memorandum at Groblersdal Police Station on Wednesday 7 February. The ANC demonstrators were complaining against racism during the court appearance of two farmers, Piet Groenewald and his stepson Stephan Greef, after they allegedly assaulted a Namibian national and later set a dog on him. Radingwana, who is also a prominent taxi owner in Groblersdal, claims he was allegedly attacked by marching ANC Youth League members in Groblersdal Town when he was on his way driving to the taxi rank. He said he was attacked because his minibus taxi was bearing BPSA stickers. "A group of young men suddenly approached and blocked my way while starting to smash my windscreen. They later took my BPSA bucket hat and left. The attack happened in full view of the party's leadership including ANC Sekhukhune Regional Secretary Tala Mathope who uttered f\*\*k you words towards me at the time," he said. Radingwana said he had not opened any case, however, his party had escalated the matter to the ANC leadership in the region. Seun Mogotji, BPSA Leader, said they were very disappointed with the attitude and inhuman behaviour displayed by the ANC Youth League members on the BPSA councillor. "It is worrisome because this happened in front of ANC secretary in Sekhukhune and he just looked and did nothing to stop that act of hatred and political intolerance," he said. Mogotji said he tried to contact Mathope telephonically to try and resolve the matter but his calls were not answered, however, he ended up sending a letter to him to demand the bucket hat that was taken by his members during the attack. "We also appealed to Mathope to educate those youth league members to shy away from political intolerance and to teach them a difference between being revolutionist and being an anarchist," he said. ANC Spokesperson in Sekhukhune Region, Sam Uwane, has confirmed that the matter was reported to the office of the regional secretary. However, Uwane has rejected allegation that the Regional Secretary Tala Mathope uttered the words "f\*\*k you" words to the BPSA councillor. "The alleged incident happened during the march and because of the number of the people who were marching, the regional secretary could not see what happened," he said. Uwane said the party condemns the incident

if it really happened and should it be proven that the damages were caused by the marchers, the ANC is prepared to responsibility cost for repairs of the windscreen as reported.

## **Groblersdal Groenewald** case postponed

Piet Groenewald (63) and his stepson, Stephan Greeff (27), were denied bail during their appearance at the Groblersdal Magistrate's Court on Monday 12 February. The duo was arrested earlier last month after allegedly brutally assaulting and setting a dog on a Namibian national, Veneruru Kavari (30). They were arrested and are currently facing charges of assault with intent to cause Grievous Bodily Harm (GBH). National Prosecuting Authority (NPA) Spokesperson in Limpopo, Mashudu Malabi-Dzangi, said the bail was not granted after the court remarked that Groenewald had previous convictions. "It was established during the court proceedings that during the incident, the complainant was kidnapped with a bakkie belonging to the security company of the accused and was brought back to Groblersdal. The complainant was also told to tell the police that he was not kidnapped. The court said that there is likelihood that the accused can interfere with state witness should they be granted bail," she said. Malabi-Dzangi said the pair remained in custody and the case was postponed to 11 March 2024. During the previous court appearance on Wednesday 7 February, the court heard from the investigating officer that Groenewald had once absconded his bail conditions after he was arrested in the 1990s. The court heard that Groenewald was re-arrested in 2002 and was sentenced to 20 years imprisonment until he was released on parole in 2010. The investigating officer stated that he should not be granted bail as he is more likely to run away and he could also interfere with state witnesses. During the duo's court appearances, different political parties were seen outside the court chanting that they should not be granted bail. However, Democratic Union Party (DUP) Leader, Tonic Mancidi, has called for political parties in Limpopo to stop interfering and let the law take its course in the case. "We call for calm and unity, and for the court not to be swayed by protesters of different political parties and the farmers who continue to protest outside during the proceedings. However, the DUP frowns upon racism and believes that perpetrators must be brought to book," he said. Manchidi said the party calls for a dialogue of all stakeholders to find a permanent solution to this problem.

# Ramathuba pays unannounced homage to Jane Furse and Groblersdal Hospitals

Following numerous complaints about pregnant women sleeping on the floor due to shortage of beds, Limpopo MEC for Health, Dr Phophi Ramathuba, has recently paid unannounced homage at Jane Furse Hospital to verify the claims. During the visit, the MEC discovered that all pregnant women had beds, however, in the previous night two pregnant women arrived around 2am and all the beds were full, therefore the midwives had to improvise and accommodate them on the mattresses. According to the department, the other challenge was experienced earlier this month when 15 pregnant women were admitted for elective caesarean sections which resulted in shortage of beds. Ramathuba said the shortage is caused because Jane Furse Hospital attracts more patients and its maternity is one of the busiest in the province where on average, they deliver around 400 a month. "Their maternal mortality is one of the lowest in the province while their perinatal outcome is also good. Unfortunately their good performance has resulted them in attracting patients from all over to want to deliver at Jane Furse and we need to discourage that by making sure all our facilities improve their performance," she said. Ramathuba indicated that the other contributing factors to the shortage of beds include accessibility in terms of transport hence patients prefer Jane Furse. "A temporary measure was put in place where an extra cubicle was identified, extra beds will be sorted and fitted in the identified area to address this challenge," she said. Meanwhile Ramathuba had also conducted a support visit to Groblersdal Hospital, where she engaged in a walkabout. She expressed satisfaction after witnessing

the hospital's adherence to the 8-day menu cycle, which has been rolled out across all healthcare facilities in the province.

# Shortage of beds marred Groblersdal Hospital

The Democratic Alliance (DA) in Limpopo said it has requested the South African Human Rights Commission (SAHRC), to investigate the horrendous conditions and serious shortage of beds for mother loggers and heavily pregnant women at Groblersdal Hospital. The party said the discovery was encountered on a recent oversight visit to the hospital recently. Linda Wilson, Da Spokesperson for Health in Limpopo, said during the oversight visit, the party discovered that the hospital still operates with an old infrastructure, with small space available and a serious shortage of beds in the maternity ward. "The conditions at Groblersdal Hospital, puts the health and well-being of patients at risk. The hospital is far too small and maternity patients at the hospital are crammed into the little space available and many pregnant women are forced to sleep on mattresses on the floor. The situation is so dire that even benches are used to accommodate the overflow of patients," informed Wilson. She added that the hospital infrastructure is neglected and crumbling. "The hospital, that caters to approximately 200 patients daily has never had additional infrastructure built by the Limpopo Department of Health," explained Wilson. According to Wilson, the hospital faces severe challenges due to the overwhelming influx of patients from surrounding areas as far as Mpumalanga, and a large number of patients from accidents on busy roads around the hospital such as the N11 and R25 Roads. "The hospital initially had 22 beds and now it has 53 beds crammed into the same space. The entire hospital only has 2 theatre beds and both are not fully functional. There are severe staff shortages including doctors, nurses, ambulance staff, cleaning and garden staff. The hospital has 11 ambulances but can only make use of two due to staff shortages," she said. Wilson indicated that the hospital is also experiencing outdated and broken equipment, insufficient equipment like autoclave machines, incubators and warmers, lack of vital medical supplies and a need for more beds in all of the hospital's wards. She said the DA will write to Health MEC in the province, Dr Phophi Ramathuba, urging her to prioritize the revitalisation of the hospital and to address the severe staff, bed and equipment shortages as a matter of urgency. "The staff at the facility are dedicated but need to be supported in their efforts to save lives," concluded Wilson.

# Operation Vala Umgodi pounce on illegal miners

The Limpopo Illegal Mining Task Team, through Operation Vala Umgodi, has nabbed four suspects in Saaiplaas outside Monsterlus on Thursday 8 February. Operation Vala Umgodi steadily stamps the authority of the state through joint efforts with relevant police units and external stakeholders that include South African National Defence Force (SANDF), Department of Mineral Resources and Energy as well as Department of Home Affairs in Limpopo. Limpopo Provincial Police Spokesperson, Colonel Malesela Ledwaba, said the arrested suspects were found red-handed mining sand in Saaiplaas illegal mining site without proper documentation, as per the National Environmental Act. "Police confiscated mining equipment that included a trailer with a gas tank, a diesel pump and a TLB front loader," he said. Ledwaba said moreover, a total number of seven male suspects were arrested and charged for Contravening the Immigration Act in Sekhukhune District. Ledwaba added that Members of Illegal Mining Task Team, during the execution of Operation Vala Umgodi, while raiding at Tinmyne policing area in Waterberg District, have pounced on four male suspects, aged between 37 and 47 in the process of illegal mining activities. "In addition to the arrests, illegal mining equipment were confiscated in Mankweng and Lebowakgomo, which included an Isuzu truck and TLB at the mining sites," he said. Furthermore, Ledwaba said the police in Driekop have apprehended three suspected illegal miners, aged between 19 and 32 at Mooihoek illegal mining sites around Sekhukhune. "It was reported that members of the Illegal Mining Task Team received information from a reliable source about illegal mining activities being carried out in Mooihoek, and they swiftly followed up with the information. Upon arrival, the team in conjunction with members of the SANDF, they pounced on three male suspects with two tipper trucks loaded with chrome and one TLB plant machine was in progress of loading chrome into the tipper trucks," explained Ledwaba. He said the police managed to arrest the three suspects and confiscated the two tipper trucks and a TLB machine for the purpose of investigations as exhibits. "In separate locations across the province, occurred on Monday 5 February 2024 during Operation Vala Umgodi, the police arrested six foreign nationals, aged between 26 and 42 for dealing in thousands of rands worth of illicit cigarettes and three male suspects were nabbed for contravention of the road traffic act in various offenses respectively. All the accused were charged and issued with the fines and were ultimately released," he said. Ledwaba said the suspects are already appearing before different magistrate's courts in the province and police investigations are underway. Acting Provincial Commissioner of the Police in Limpopo, Major General Jan Scheepers, has applauded the members of the Police Task Team and the SANDF for their collaborative efforts that yielded tangible and meaningful successes in riding the province from illegal mining and crime.

#### DA approaches Green Scorpions over spilling SDM raw sewerage

The Democratic Alliance (DA) in Limpopo has on Monday 12 February filed a complaint with the Environmental Management Inspectors (Green Scorpions), against the Sekhukhune District Municipality (SDM) and Elias Motsoaledi Local Municipalities (EMLM) for raw effluent spills into water sources in the area. According to the DA, the complaint was laid after the discovery of raw, untreated effluent that is running into the Olifants River near Groblersdal Town and surrounding villages. "These charges were laid due to the violation of Section 107 of National Environmental Management Act and Section 24 of the Constitution for the non-functioning wastewater treat-

ment plant in Groblersdal, which continues to pollute the environment," said Lindy Wilson, DA Spokesperson for Cooperative Governance, Human Settlement and Traditional Affairs (CoGHSTA) in Limpopo. "The spillage does not only pose the risk of a cholera outbreak, but also destroys plant and animal life and the safety of livestock drinking from the river," she said. Wilson further said during a recent oversight conducted to the wastewater treatment plant, the party discovered that no pumps were in working condition and the aerators were also non-functioning. "We have also discovered that the clarifiers were not operational, no E-Coli testing is being done and no chlorine was available to treat the water," she said. Wilson indicated that the party is concern because the officials working there are at risk, not only because of the conditions at the plant, but they have noticed that there is a crocodile living on the site in the tall shrubs. "Another worry is that raw effluent runs directly into the Olifants River and the stench on site was unbearable which nearby communities are exposed to it daily," she said. Wilson said the party will invite the MEC for CoGHSTA in the province, Basikopo Makamu, to personally visit the wastewater treatment plant to familiarize himself with the mess and stench created through the neglect and incompetence of his ANC run municipalities. "The DA will not

allow further compromise of service delivery to the residents of Elias Motsoaledi local Municipality by the unconstitutional behaviour of ANC cadres and will cooperate with the Green Scorpions during their investigation," she said.

### BPSA dismay over D856 Road poor workmanship

The Bolsheviks Party of South Africa (BPSA) has written to the office of the Public Protector (PP) of South Africa to complain about shoddy workmanship on the newly constructed D856 Road that links Moteti and Dennilton. The road was rehabilitated about a year ago by Roads Agency Limpopo (RAL), however, it has started to peel off a year after its construction. BPSA Leader, Seun Mogotji, said they are seeking an urgent intervention of the PP to deal with unscrupulous contractors who used poor quality material to deliver substandard work.

"The intervention of Public Protector's office is urgently needed where a contractor was given a tender to revamp this road, but it seems like he has no expertise or experience about road construction at all," he said. Mogotji added that a portion of that road, which he said was signed off

as complete project and handed over about 12 months ago, looks horrible, even worse than it was before it was revamped. "Something does not add up, how can engineers and the consultants can miss all those red flags



which can be seen by a layman passing by with no decorated degrees?" asked Mogotji.

Mogotji indicated that the road is of poor quality and by the look of things, the developers had just cut corners and pocketed the money. "There is so much sand that covers the road every time it rains. It looks like the culverts are not there or the ones that are there are blocked because the amount of water that covers that road when it rains is just too much," explained



Mogotji. He said to make matters worse, the same contractor who delivered shoddy workmanship has been given a go ahead to start digging up and constructing the road from Philadelphia to the R25 T-Junction, despite his failure to deliver quality work in the previous project. "That road was constructed during the apartheid era and is of good quality. We believe now they are going to mess it up and replace it with poor quality using substandard material. We want the PP to get rid of this contractor before he messes all the roads in the area," concluded Mogotji.

RAL Head of Communication, Danny Legodi, said the agency is investigating and will respond after the investigation is finalised.

#### Alleged house robbery suspect killed in mob justice attack

The Police in Dennilton are investigating a case of murder after a group of angry residents of Waalkraal in Moutse, allegedly took the law into their own hands and killed an alleged burglary and house robbery suspect.

The incident occurred in the early hours of Friday 9 February at Waalkraal Phase 8. According to Colonel Malesela Ledwaba, Limpopo Provincial Police Spokesperson, police preliminary reports indicate that the unknown suspect went to the house belonging to a male victim where he knocked on the door, and when the victim opened, he pointed him with a firearm. "The victim managed to push the door back and blew the whistle for assistance. Community members responded in numbers and started chasing the suspect until they caught him. They then assaulted him, and he allegedly admitted that he was the one who broke into the victim's house days ago, where groceries as well as a water storage tank were stolen. The victim had never reported the matter to the police," explained Ledwaba. He said after the confession, some of the community members took the victim, who was severely assaulted to the local police station and the emergency medical services were summoned and the man was certified dead upon arrival at the hospital. "The police went to the place where the stolen items were allegedly found hidden inside a certain vehicle and upon arrival, the vehicle, as well as the stolen properties were not discovered," said Ledwaba. He said the police have opened a case of house robbery, burglary and murder for further investigation. "The toy gun used to commit the crime was confiscated. The deceased is an African male in his twenties and is not yet known," he said. Ledwaba said the police appeal to anyone with information that can assist in identifying the deceased or in tracing the suspects involved in mob justice to contact Dennilton Detectives on 082 303 9907, crime stop number on 08600 10111, the nearest police station or make use MySAPSApp.

Major General Jan Scheepers, Acting Provincial Commissioner of the Police in Limpopo, has condemned the mob justice incident, saying that the community members continue to act irresponsibly and take the law into their own hands. "This clearly indicates that the public should report suspected criminals to police, who will be able to arrest all perpetrators as well as to recover the exhibits.

The suspects responsible for mob justice should be arrested and face consequences of their actions," concluded Major General Scheepers.

#### Operations Kakula yield positive results

The police members in Limpopo Province, together with other stakeholders including Department of Home Affairs and private security companies, have arrested a total of 1651 suspects during Operations Kukula that were conducted in all five district in the province from Monday 5 February to Sunday 11

Colonel Malesela Ledwaba, Limpopo Provincial Police Spokesperson, said the suspects were arrested for charges including murder, attempted murder, robberies, rape, sexual offenses, assaults, burglaries, fraud, theft, malicious damage to property, public drinking, drug related cases and contravention of Immigration Act. "The operations were conducted through roadblocks, stop and search, blue light patrols, compliance inspections at liquor premises, and second-hand dealers,

amongst other duties. The police also recovered seven stolen or hijacked motor vehicles during operations," he said. Ledwaba said during the operations, 20 suspects were nabbed for transgression of the Do-Violence mestic Act, 393 suspects for contravention of Immigration Act and 117 suspects for drug related crimes. "The drugs confiscated were 1552.174 grams of dagga, 1 dagga plant, 4.601 grams of crystal meth and 34 grams of nyaope. Police recovered nine firearms, 28 knives, 32 dangerous weapons, 604 162 counterfeit sticks, and 569627. 5 ml of liquor," explained Ledwaba. He added that the police had also during the operations attended to about 549 reports of domestic violence and 281 protection orders were served. "The suspects have started to appear before various magistrate's courts across the province. The police investigations are continuing," he said. 

#### Sekhukhune Golf Federation structure to be launched
