DA Limpopo calls for interrogation of GNT's affairs The DA in Limpopo has called for an

SEKHUKHUNE(LIMPOPO)

The Democratic Alliance (DA) in Limpopo announced that the party has written to the Chairperson of the Limpopo Portfolio Committee on Economic Development, Environment and Tourism (LEDET) for an urgent meeting with the management and board of Great North Transport (GNT) to interrogate the financial sustainability, effectiveness and integrity of the company's turnaround strategy.

Jacques Smalle, DA Provincial spokesperson for LEDET, said they are particularly calling for the purchase and leasing of buses and the outsourcing of routes to be subjected to full scrutiny in order to determine whether the transactions are in the best interest of GNT, can withstand oversight and are above reproach.

Smalle stated, "In our letter, we also call for the executive and board of Limpopo Development Agency (LEDA), the GNT's shareholder, to be present at the meeting. As the DA, we received worrying representation from various interested and affected

parties alleging impropriety. Corrupt and malfeasant governance practically collapsed GNT, were it not for repeated bailouts from the fiscus. We simply cannot afford, and will no longer accept, a situation where current attempts to turn around and recapitalise GNT are once again mired in inefficiency and corruption."


He indicated that they have also received reports that the outsourcing of routes is rendering GNT staff, including its drivers, maintenance personnel and some depot operations redundant.

"This further calls into question the coherence, objectives and rationality of the entity," added Smalle.

The party urged the committee to hold the executive and board of GNT to account and monitor, investigate and enquire into the company's purchasing and leasing of buses as well as the outsourcing of routes. "We cannot allow for bailouts to sustain ongoing failure," concluded Smalle.

EFF calls for relief from sand mining restrictions in Sekhukhune

GROBLERSDAL

The Economic Freedom Fighters (EFF) in Sekhukhune Region has recently tabled a motion to persuade the Department of Mineral Resources and Energy (DMRE) to reconsider its sand mining restrictions in the region.

EFF Councillor in Sekhukhune District Municipality (SDM), Ali Maloba, tabling the party's motion before the council, argued that these restrictions have crippled the local bricks and sand business, threatening the livelihoods of many community members.

According to Maloba, over 200 community members were arrested between January 1 and April 1, 2025, for engaging in sand mining activities without permits.

Community members arrested for sand mining are required to pay admission of guilt fines of R1,

500

Maloba said it is unfair that the DMRE has only issued permits to three companies in Elias Motsoaledi, all of which are whiteowned, effectively monopolizing the industry.

"This has left many blackowned businesses struggling to survive," he said.

During the motion, the EFF had also raised concerns over the lack of consultation with local communities, municipalities, and traditional leaders before implementing the restrictions.

"We argue that this decision has been made without considering the impact on local Small, Medium and Macro Enterprises (SMMEs) and the broader community. Communities and stakeholders were not consulted before the implementation of the restrictions," he said.

Maloba indicated that the DMRE's decision to effectively give two white-owned companies sand mining rights in the industry in Sekhukhune has negatively impacted local businesses which are now struggling to survive due to the restrictions, with some on the brink of collapse.

"The EFF is calling on the DMRE to reconsider its restrictions and engage with local stakeholders to find a solution that supports local businesses and communities. We argue that proper stakeholder engagement is necessary to regularize the operations of sand mining communities and prevent potential unrest," he said.

The motion is expected to be discussed at the next council sitting in SDM Offices Bareki Mall, Groblersdal.

Operation Vala Umgodi apprehends illegal immigrants and illegal miners

The Police in Limpopo have arrested 16 illegal immigrants and 2 illegal miners during the ongoing Operation Vala Umgodi, conducted on Wednesday 14 May 2025, targeting areas such as Jane Furse, Malamulele and Maake respectively.

Colonel Malesela Ledwaba, Limpopo Provincial Police Spokesperson, said in the Sekhukhune District, four male suspects were arrested for contravention of immigration laws in the Jane Furse Policing area, while one suspect was arrested at Ga-Molepane Village.

"In the Vhembe District, 7 suspects were arrested for contravention of immigration laws in the Malamulele Policing area. In Mopani, 3 suspects, aged between 19 and 29, were arrested for contravention of immigration laws, and one suspect was arrested for illegal mining," explained Ledwaba.

He added that during the operation, the police team recovered equipment such as phendukas, spades, shovels and pickaxes.

"Furthermore, a TLB earthmoving machine was confiscated in the Jane Furse Policing area, and a white Toyota tipper truck and 2 shovels were confiscated in the Maake Policing area," he said.

Ledwaba said the suspects will appear before their local magistrate's courts soon and the police investigations are ongoing.

Operation Shanela yields significant results across Limpopo

The Police in Limpopo have reported significant strides in the intensified high-density Operation Shanela, focusing on the removal of illegal firearms and addressing the influx of undocumented foreign nationals.

The operations were conducted from Monday 12 May until Sunday 18 May 2025 and resulted in the arrests of 1,392 suspects across the province for various crime categories.

Colonel Malesela Ledwaba, Limpopo Provincial Police Spokesperson, said during the operation, police members confiscated six illegal firearms and huge quantities of ammunition.

"A substantial portion of the operation focused on immigration compliance, leading to the arrest of 259 undocumented foreign nationals. This is part of a broader SAPS strategy to enhance border security and ensure law

enforcement presence across communities," said Ledwaba.

He added that during the operations the police made notable arrests where 7 suspects were nabbed for murder, 2 for attempted murder, 15 for rape, 18 for other sexual offences, 96 for assault with intent to cause grievous bodily harm (GBH) and 62 for common assault.

"Another 96 suspects were arrested for drug-related offences, 22 for driving under the influence of alcohol and 18 for violations related to domestic violence," said Ledwaba.

He indicated that the Operation Shanela also resulted in the confiscation of large volumes of contraband and the recovery of stolen goods, including 133,371 counterfeit cigarette sticks, 787,055 ml of illegal liquor, with 43 arrests for illegal liquor trading, various quantities of narcotics, including dagga, crack cocaine,

crystal meth, heroin, and nyaope, 48 dangerous weapons and eight stolen or hijacked vehicles recovered.

"The success of the operation was driven by high-impact policing actions, including 7,626 stop-and-search operations, 106 roadblocks set up across the province, 1, 113 spaza shops/tuck shops inspected, 2,976 liquor outlets checked, resulting in the closure of 50 illegal shebeens," informed Ledwaba.

He said the arrested suspects have started appearing at their respective local magistrates courts. Provincial Commissioner of the Police in Limpopo, Lieutenant General Thembi Hadebe, praised the collaborative efforts of law enforcement, stating that Operation Shanela is yielding tangible results in addressing the safety concerns of Limpopo residents, visitors, and the business community.

The Police in Mmamethlake outside Siyabuswa have arrested a 59-year-old suspect for the rape of an 8-year-old girl in the Newstand Section of Mmametlhake on Wednesday 14 May 2025.

Mpumalanga Provincial Police Spokesperson, Lieutenant Colonel Jabu Ndubane, said according to information received, the incident reportedly occurred at approximately 17:30, when the victim was playing in the yard with her friends.

"She was suddenly called over by a well-known man passing along the street, took her to a nearby spot, and raped her," he said.

Ndubane added that after the incident, the victim returned to her friend crying and upon arriving in the yard, she informed her friends that


He said the suspect, who cannot be named to protect the identity of

recent downpours have caused extensive damage to roads across the country, with many routes becoming impassable due to waterlogging and erosion. The persistent rainfall has led to severe wear and tear, resulting in the formation of potholes and the deterioration of already vulnerable road surfaces.

In addition to the ongoing project, the municipality has initiated a Regraveling Programme, structured according to clusters. "This initiative seeks to upgrade road infrastructure, improve accessibility, and promote safer travel for all road users," he added.

Through these interventions, the municipality aims to create a road network that is effective, safe, and sustainable—meeting the day-to-day needs of local communities.

The Elias Motsoaledi Local Municipality has committed to providing regular progress updates to keep residents informed on the implementation and status of these infrastructure improvements.

Limpopo job crises deep

The political party's call follows the release of the latest Quarterly Labour Force Survey Stats SA report for the first quarter of 2025, which indicates that Limpopo lost a staggering 55,000 jobs between the fourth quarter of 2024 and the first quarter of 2025. This accounts for nearly 20% of the jobs lost nationally.

The survey indicates that unemployment rate reaches alarming levels with the provincial expanded unemployment rate in Limpopo stands at an astounding 48.6%, which is the third highest in the country.

This includes those citizens of Limpopo who have lost all hope of finding work. The statistics revealed that nearly one in every two working-age people in Limpopo is now unemployed or discouraged. Only 36.5% of Limpopo's working-age population are employed, which is well below the national average.

DA Limpopo Provincial Leader, Lindy Wilson, emphasized that these numbers are not just statistics, but a reflection of the lived reality of many Limpopo residents, particularly young people, who are being left behind in an economy that is failing them.

"The impact of bad municipal governance, the collapse of municipal infrastructure and service delivery, and the lack of political will by the ANC-led provincial government to intervene, has clearly increased the provincial misery," she said.

Wilson said the DA is calling on the provincial

administration to successfully roll-out infrastructure projects, maintain existing infrastructure, and drive economic growth and diversification.

"The failure of LEDET and LEDA to achieve these goals has contributed to the province's economic woes. The DA has joined the GNU to fight for economic growth and job creation, and for the bold reforms needed to reverse the growing catastrophe," explained Wilson.

The Provincial Leader said the DA believes that unlocking the barriers to investment and growth, such as job, labour, and economic regulations that protect narrow interests at the expense of all South Africans, is crucial to addressing the jobs crisis.

"A job is more than a source of income; it provides hope for the future, security, and dignity. Better and more responsible governance in Limpopo is also essential to reversing the trend," concluded Wilson.

akhuduthamaga Local Municipality (MLM)'s leadership met with Limpopo MEC for Public Works, Roads and Infrastructure, Ernest Rachoene at the council chamber in Jane Furse on Monday.

The meeting is a critical followup engagement seeking to address persistent service delivery concerns related to D-Roads and government property management in the main.

Mayor Merah Mahlase, Municipal Manager Ronald Moganedi, Council Speaker Judy Nkgadima, Chief Whip Mosedi Thamaga and senior officials of the department engaged in the session.

Thomas Mashabela, MLM spokesperson, said the issues of unregistered government buildings and unpaid property rates as well as the implementation of D-Roads projects dominated the discussions.

MLM reiterated the need for fast-tracking of key D-Roads projects or devolving some of them to the municipality, technical designs of which have already been completed.

According to the municipality, the D-Roads are essential for rural access and community development and their delay in execution continues to affect service delivery as well as economic mobility.

Also brought to the attention of MEC Rachoene's attention was numerous public buildings within the municipality that remain unregistered.

It was revealed in the meeting that the aforementioned properties are not being billed for property rates, severely straining the municipality's revenue base and its capacity to deliver essential services.

Nkgadima and Thamaga emphasised on the importance of accountability and improved intergovernmental coordination.

The MEC commended the municipality for its proactive approach and assured the leadership that the concerns raised were receiving priority attention from his department.

Rachoene announced plans for the initiation of a verification and audit process to address the issue of unregistered public buildings, with the aim to resolving ownership discrepancies and enforcing proper billing.

Furthermore, the MEC highlighted that the department, in coordination with Road Agency Limpopo (RAL), will review the list of D-Roads projects submitted and remove barriers to their implementation.

He reaffirmed his commitment to strengthening collaboration between the provincial and local government structures and praised the municipality for its dedication to advancing service delivery.

Mashabela stated that in order to ensure continued momentum, the meeting agreed on a follow-up engagement soon where progress on both the property audit and D-Roads project implementation will be reviewed.
