





DA Limpopo lambasts state of Emergency Medical Services

LIMPOPO

he Democratic Alliance (DA) in Limpopo has raised concerns over the Emergency Medical Services (EMS) in the province.

According to the DA, innocent lives remain jeopardised as the services in Limpopo collapse. Lindy Wilson, DA Limpopo spokesperson for Health, said the party demands that the Minister of Health, Dr. Aaron Motsoaledi, intervenes in the collapsed EMS in the province.

Wilson stated that of great concern is the lack of qualified ambulance crews to administer life-saving interventions for patients requiring critical care.

"After much grandstanding and fanfare around the handover of dozens of new ambulances to public facilities around the province, very few have qualified crews to operate them. In fact, the DA is advised that there are only four advanced medical practitioners in the province," Wilson pointed out.

She alluded that paramedics and EMS personnel are required to complete a Higher Certificate in Emergency Medical Care, the most basic life support requirement – very basic paramedic, a Diploma in Emergency Medical Care or a Bachelor's Degree in Emergency Medical Care for Advanced Medical Practitioners.

"The majority of the crews on ambulances only have the basic Certificate in Emergency Medical Care and are not qualified to administer life-saving interventions like intubation. As a result, critical patients' lives have been put at risk by inadequately qualified personnel to assist where necessary. The crisis is made worse by the fact that neither the Thazimbi nor the Capricorn training facilities in Limpopo are operational. Neither has met the accreditation criteria required by the Department of Higher Education and therefore, potential students for the EMS services are forced to travel to alternative provinces for training," added Wilson.

She indicated that Medivac helicopters, which should have one Advanced Medical Practitioner on board to fly patients to hospitals, are released with emergency medical personnel, which do not meet the requirements as laid out in the Act.

"In Limpopo province, where medical legal claims already run into billions, the situation has reached crisis point. Confidence in MEC Mashego and the Department of Health in Limpopo has all but disappeared. The DA will take a stand against the abysmal state of healthcare administered to our poor vulnerable citizens and will ensure that every possible action is taken to protect concluded them,"

Wilson.

Leeuwfontein RDP residents demonstrate over crime and unemployment concerns

LEEUWFONTEIN - The community of Leeuwfontein RDP Section in Ephraim Mogale Local Municipality (EPMLM) has on Monday 26 May 2025 staged a protest raising complaints about pressing concerns set to make an impact with the closure of affecting the community, high crime rate in

The community said the area is plagued by various criminal issues, including frequent killings, armed robberies, and house break-ins which have created a sense of insecurity among residents. They also raised concerns about spiking unemployment rate in the area which they say is significantly high, contributing to economic instability and social unrest.

The Leeuwfontein community feels that law and order are not being adequately enforced due to a lack of police visibility. They are also concerned about the high volume of illegal foreign nationals in the area, which they believe is exacerbating existing problems such as crime and high unemployment rates at local farms.

Community Leader, John Leshilo, told

the publication that the protest was sparked by the recent killing of one of residents who was murdered on 18 April 18 2025.

Leshilo stated that the protest was all main roads in Leeuwfontein and also impact normal traffic flow. However, the demonstrators were dispersed by the public order police before the protest could

A meeting was convened with the police in the morning in which the protesting community was promised that a relevant police delegation will be sent in the area to address the high crime issues.

"We are happy with the outcomes of the meeting but the community has given the police an ultimatum, stating that if they fail to attend to their concerns, they will stage another protest soon," said Leshilo.

Currently, the situation remains tense at Leeuwfontein, and the community is eagerly awaiting the police delegation's visit to address their safety concerns.

GNT pension and medical aid contributions matter receives intervention

Great North Transport employees affected by the company's hardships to make contributions to the pension and medical aid payment could breathe a sigh of relief.

This is following the recent announcement by the Limpopo Economic Development Agency (LEDA) to fast-track payment of the outstanding cases. Thakani Makhuvha, LEDA Group Chief Executive Officer has highlighted the significance of GNT's turnaround plan and confirmed that LEDA would step in to close the gap caused by non-payment of the critical employee benefits.

Makhuvha stated that they have taken an important decision, as GNT's shareholder, to make the necessary payments and bring all outstanding contributions up to date. "We are hopeful this situation will not recur," said Makhuvha.

Major breakthrough in Roossenekal farm attack investigation

ROOSSENEKAL - In a significant breakthrough that has been achieved in the ongoing investigation into serious violent crimes in Limpopo, a 29-year-old suspect, Bazali Mathebula, was arrested in connection with the brutal murder of a Roossenekal farmer, Robert Scholtz, who

was killed at his farm recently.

The suspect appeared before the Groblersdal Magistrate's Court on Friday 23 May 2025, following a successful intelligence-driven, multi-disciplinary operation

Brigadier Hlulani Mashaba, Limpopo Provincial Police Spokesperson, said the operation led to the recovery of four unlicensed firearms and 218 rounds of ammunition, some of which have been linked to the brutal farm murder of Scholtz earlier in May 2025.

"The joint operation was conducted on Tuesday 20 May 2025, and involved members of the Sekhukhune Tracking Team, Roossenekal Police, supported by BMO Security Company. Acting on credible intelligence, officers apprehended the suspect and recovered a disassembled shotgun, which investigations later confirmed was linked to the Scholtz murder case. The suspect was granted bail of R4, 000 bail and the case was remanded to 23 June 2025, for further investigation," explained Mashaba.

the suspect's residence yielded a substantial weapons cache, including the recovery of a rifle with a magazine and ammunition, two shotguns, a pistol with ammunition and a total of 218 rounds of ammunition in various calibers.

"Preliminary findings indicate that the recovered firearms were the property of a private security company based in Thulamashe, whose director is now deceased," Mashaba said.

Mashaba said the investigation into the murder of Robert Scholtz remains ongoing, and additional arrests have not been ruled out as the probe continues.

The Provincial Commissioner of the Police in Limpopo, Lieutenant General Thembi Hadebe, has highlighted the effectiveness of intelligence-led policing and strong inter-agency collaboration in tackling serious crimes impacting rural communities.

Operation Vala Umgodi crackdown on illegal miners and illegal migrants

MARBLE HALL - The Police in Limpopo have made significant strides in disrupting illegal mining activities and related crimes through Operation Vala Umgodi, conducted on Friday 23 and Saturday 24 May 2025, with the arrests of 22 suspects, aged between 18 and 52, for contravention of the immigration act in the Marble Hall and Makhado policing areas. Brigadier Hlulani Mashaba, Limpopo Provincial Police Spokesperson, said in Marble Hall, 19 suspects were arrested during patrols and stop-and-

search operations, while three suspects were arrested in Makhado.

"The police also seized abandoned items, including shovels, pickaxes, and a Mitsubishi truck, after suspects fled the scene on foot. The arrested suspects will appear before the local magistrate's courts soon, and police investigations are ongoing," he said.

Mashaba said the police continues to crack down on illegal activities, ensuring the safety and security of communities in Limpopo.



GROBLERSDAL - The Police Operation including copper wires, shovels, pickaxes, Vala Umgodi, which were executed at Groblersdal and Vuwani policing areas on Sunday 25 May 2025, resulted in the arrest of seven suspects, aged between 18 and 39, for various offenses, including illegal mining, possession of suspected stolen properties, and contravention of immigration laws. The arrests were made during operations conducted separately at the Groblersdal and Vuwani policing areas respectively. Colonel Malesela Ledwaba, Limpopo Provincial Police Spokesperson, said in Groblersdal, five suspects were arrested after members of Operation Vala Umgodi responded to a tip-off about a suspicious silver grey Mercedes Benz at an old mine.

"Upon searching the vehicle, the police found suspected stolen properties,

and side cutters. The suspects were also charged with contravention of immigration laws after failing to produce passports," explained Ledwaba.

He added that in the Vuwani policing area, two suspects were arrested for illegal mining and contravention of immigration

"They were found mining illegally at Hamanavhela Mahebe River," Ledwaba said. He said during the operation, the police also confiscated abandoned items, including 5 brick moulds, 3 spades, and 3 wheelbarrows, at Dzondo River in Mvelaphanda area.

"The suspects will appear before their local magistrate's courts soon. Police investigations are ongoing," concluded

Seven-hundred and sixty-four nabbed in Shanela Operation

LIMPOPO - A total of 764 offenders were nabbed while three firearms confiscated during the Shanela/Kukula Operation executed across the five districts of Limpopo province between 19 May and 25. The suspects were apprehended for various offences with a total of 427 nabbed for contravention of the Immigration Act.

Colonel Malesela Ledwaba, Limpopo Provincial Police spokesperson, said additionally, the operation resulted three suspects arrested for murder, nine for attempted murder, 10 for rape, 55 attempted rape, nine for other sexual offences, 22 for assault with intent to cause Grievous Bodily Harm, three for business robbery, 1 for house robbery, three for illegal possession of firearms, 22 for possession of dangerous weapons, seven for illicit cigarettes, four for burglary business and eight for malicious damage

Ledwaba stated that 33 more were banned for assault common, 96 for drugrelated offences, six for driving under the influence of alcohol, 48 as wanted suspects and 181 for other crimes.

"The operation further resulted in the confiscation of large volumes of contraband and recovery of stolen goods. Fifteen Thousand one-hundred and eighty counterfeit cigarette sticks, 787ml of illegal liquor with 43 arrests for illegal trading, various quantities of narcotics including crack cocaine, heroin as well as nyaope, 12 dangerous weapons and cellphones were confiscated," added Ledwaba.

He attributed the success of the operation to high-impact policing actions, including 2073 stop-and-searches, 37 roadblocks set up across the province, 378 second-hand goods dealers inspections, 314 scrapyards checks and 1201 liquor outlets inspections, resulting in the closure of 16 illegal ones.

The Provincial Commissioner of South African Police Services in Limpopo, Lieutenant General Thembi Hadebe has welcomed the successes achieved during the operations and commended the role players for their continued efforts in the fight against crime.


