# Shocking video sparks investigation into Matlala

#### **TSIMANYANE**

he Limpopo Department of Health has on Monday 5 March 2025 launched an investigation into a circulating social media video, alleging neglect and prolonged waiting times at Matlala Hospital in Tsimanyane outside Marble Hall.

In the video, a mother claims she and her sick child were left unattended for over seven hours without assistance to open a patient file.

Health Department Spokesperson in Limpopo, Percy Moagi, said the department has initiated an internal enquiry to establish the facts surrounding the incident, including verifying the exact date and time of the video and identifying the individuals involved.

"The department takes such allegations seriously, as no patient should be subjected to prolonged waiting without being assisted, particularly in our facilities where timely and compassionate care is expected. The dignity and health of every patient are paramount, and any deviation from these standards is unacceptable," he said.

Moagi added that the patient is being tracked to cross-reference facility records and determine the timeline of events.


"This morning, upon becoming aware of the video, the department immediately initiated an internal enquiry to establish all the facts surrounding the incident. This includes verifying the exact date and time of the video and identifying the individuals involved. Currently, the patient involved is being tracked to cross-reference the facility records and trace the patient's arrival time, movement within the hospital, and whether any consultations or interventions took place," explained Moagi.

He indicated that the department is also investigating allegations of staff absence and cleanliness concerns raised in the video.

"Regarding the concerns about cleanliness raised in the video, we acknowledge that the Outpatient Department (OPD) and casualty areas are among the busiest sections of any hospital. These areas are prioritised for cleaning regularly throughout the day. If dereliction of duty is confirmed, corrective actions will follow in accordance with departmental policies," Moagi said.

However, Moagi said they are not yet certain what the specific claims in the video pertain to, and they are reviewing the footage carefully as part of their investigation.

"The department wishes to assure the public that it is committed to ensuring all patients receive dignified, respectful, and prompt healthcare services. We appeal to the public to report any such experiences through the appropriate facility management or the department's complaints system so that immediate attention can be given to the matter," said Moagi

## Over five hundred suspect caught during Operation Shanela

#### **LIMPOPO**

The latest phase of Operation Shanela, conducted across Limpopo Province from Monday 24 April 2025 to Monday 4 May 2025, resulted in the arrests of 559 suspects.

The which operation, significantly enhanced community safety across Limpopo Province through comprehensive law enforcement actions addressed crimes ranging from violent offenses to regulatory violations that impact public welfare. In addition, 4 firearms and 28 ammunition were recovered during the operation.

Colonel Malesela Ledwaba, Limpopo Provincial Police Spokesperson, said the strategic security operation represented a collaborative approach to community protection, uniting multiple specialized police units, including the Public Order Policing, Tactical Response Team, K9 Unit, and Detective Services.

"The initiative's effectiveness was amplified through partnerships with the South African National Defence Force, Community Policing Forums, Youth Desk representatives, Traffic Departments and Department of Home Affairs," explained Ledwaba.

He said key arrests during the massive operation included, 63 suspects nabbed for contravention of the Immigration Act, two for murder, three for rape, 27 for malicious damage to property, 41 for assault GBH, 66 for common assault, two for aggravated robbery, 4 for illegal possession of firearms, 20 for illegal

possession of ammunition, 7 for business burglary, 78 for driving under the influence of alcohol or drugs,15 for possession of dangerous weapons and 181 suspects arrested for various other crimes.

"The arrested suspects are facing has charges of murder, rape, contravention of the Immigration Act, driving under the influence of alcohol or drugs, robbery, assault GBH, illegal possession of firearms and ammunition and illicit mining," he

> Ledwaba added that eighteen unlicensed liquor outlets were closed, with 27 roadblocks conducted and 13 tracing operations targeting wanted suspects were also executed.

> "Furthermore. 38 compliance inspections of firearms at non-official institution such as private security and firearm dealers were conducted, 341 farms were visited, 154 formal businesses inspected such as hospitality and retailers were raided, 3695 informal businesses inspected like spaza shops were raided, 1042 licensed liquor premises were inspected, 549 second-hand dealers were inspected, 22 mines were visited and six hostels were searched," informed Ledwaba.

> He said the arrested suspects have already started appearing before various magistrate's courts across the province.

> Acting Provincial Commissioner of the Police in Limpopo, Major General Samuel Manala, appreciated the continued efforts and commitment of all role players.

# **Massive manhunt launched** for slain Roossenekal farmer

The Acting Provincial Commissioner of the Police in Limpopo, Major General Samuel Manala, has ordered a massive manhunt for the suspects who brutally murdered a 78-year-old farmer, Robert Stoltz, who was found slain at a farm in Roossenekal outside Groblersdal.

The murder occurred on Wednesday 30 April 2025, at Stoffkraal Farm, Harteles. The deceased's body was discovered the following morning.

Colonel Malesela Ledwaba, Limpopo Provincial Police Spokesperson, said the victim was found with severe wounds on his forehead, a cloth on his mouth, and tied with wire inside his bathroom in a pool of blood.

"A blue Cherry motor vehicle belonging to the victim was later found abandoned and overturned about six kilometres from the scene of the crime. The police urge anyone with information that can lead to the apprehension of the suspects to come forward. Those with information can contact the Investigating Officer, Sergeant Millicent Mokgomogane, on 076 614 0141 or the crime stop number 08600 10111, or visit their nearest police station or use MySAPSApp," said Ledwaba.

He said the police investigations are ongoing, and the community is encouraged to assist in bringing the perpetrators to justice.

The Democratic Alliance (DA) in Limpopo has extended their condolences to the family of the victim, adding that they welcome the Acting Commissioner Manala's decision to mobilize all available

resources to track down the perpetrators.

"The DA has long emphasized the need for rural safety to be a top priority for the South African Police Service. The party believes that farm murders require urgent attention and has called for a dedicated, well-resourced specialized unit to protect rural communities," said the party's Provincial Spokesperson for the Limpopo Department of Agriculture and Rural Development, Marie Helm.

Helm indicated that the DA's call for decisive action from the police comes amid growing concerns about rural safety and the need for effective measures to prevent and investigate crimes in these

She furthered urged the police to prioritize rural safety and ensure that justice is served in this case.

# Rape convict slapped with 20 years direct imprisonment

#### **GA-MPHAHLELE**

The Thabamoopo Magistrate's Court slapped Boise Lekole Mabule (48), who has been found guilty of rape of a 12 year-old girl in Ga-Mphahlele, with a 20-year jail term on 23 April.

The court heard that the rape occurred on 31 May 2017 in Seleteng Village, Ga-Mphahlele within Lebowakgomo policing area. The court also heard the victim was returning home from church at about 18:00 when the she met the accused who is known to her.

Mabule placed sellotape over the girl's mouth and dragged her into nearby bushes where he raped her. He threatened the victim not to disclose the incident to anyone. Upon arrival at home, the victim reported the matter and a case was immediately opened at SAPS Lebowakgomo.

The case was transferred to the Family Violence, Child Protection and Sexual Offences (FCS) Unit in Lebowakgomo.

Mabule was arrested on the same day. He was found guilty in September 2023 and referred for mental observation.

Sergeant Magdaline Makopo diligently led the investigation. The Acting Provincial Commissioner of SAPS in Limpopo, Major General Samuel Manala, Has welcomed the

## Illegal immigrants nabbed in Marble Hall and Masakaneng areas

#### **GROBLERSDAL/MARBLE HALL**

Nine suspects were arrested for contravention of the Immigration Act following an operation conducted at Masakaneng Village in the Groblersdal policing area while 10 other suspects were apprehended for the same crime in Marble Hall policing area in a separate but similar operation.

The Vala Umgodi multidisciplinary operations were conducted across Limpopo province from 28 April until May 5. In the Capricorn district, three suspects aged between 21 and 38 were also arrested for illegal mining of sand at Tudumo River, Mogodi Village in Lebowakgomo policing area. A truck and seven shovels were confiscated during the arrest.

Colonel Malesela Ledwaba, Limpopo Provincial Police spokesperson, said the disruptive operations were conducted through stop and searches and patrols at identified illegal mining sites.

Specialised South African Police Service (SAPS) units, including Public Order Policing, Tactical Response Team, K9 Unit and detective services as well as the South African National Defence Force (SANDF), Community Policing Forums (CPFs), Youth Desk representatives, traffic departments and the Department of Home Affairs also ran a parallel Shanela/Kukula operations in the province at the same period.

The initiative yielded positive results, leading to the arrest of a total of 559 suspects for various offences.

Sixty-three suspects were arrested for contravention of the Immigration Act, two for murder, three for rape, 27 for malicious damage to property, 41 for assault GBH, 66 for common assault, two for aggravated robbery, four for illegal possession of firearms, 20 for illegal possession of ammunitions, seven for business burglary, 78 for driving under the influence of alcohol or drugs, 15 for possession of dangerous weapons and 181 for various other crimes.

Acting Provincial Commissioner of SAPS in Limpopo, Major General Samuel Manala, appreciated the continued efforts and commitment of all role players.

The arrested suspects have already started appearing before Magistrate's Courts across the province.
