

## MEC Mashego monitors progress at St Rita's Hospital

Health in MEC for Limpopo, Dieketseng Mashego, paid a visit to St Ritas Hospital in Glen Cowie on Thursday 4 September 2025, with the purpose of assessing hospital's progress since the unannounced visit by Minister of Health, Aaron Motsoaledi, Premier of Limpopo, Dr Phophi Ramathuba, and MEC Mashego herself on 5 August 2025.

During the August visit, the hospital's top management, including CEO Mokgano Mahloele, was publicly criticized and side-lined due to poor service delivery.

Minister Motsoaledi expressed dissatisfaction with the hospital's conditions, citing a lack of leadership and filth.

"We receive beautiful reports from HODs and CFOs, but the reality on the ground is shocking," Premier Ramathuba noted during the visit.

MEC Mashego's latest visit aimed to monitor the hospital's progress in addressing the issues raised during the previous visit.

In a statement, MEC Mashego emphasized the importance of accountability in healthcare provision, a sentiment she echoed during an unannounced visit to Knobel Hospital earlier.

"We will leave no stone unturned when addressing government employees who choose to undermine Batho Pele principles and treat the communities without humanity," she said.

The visit to St Ritas Hospital is part of MEC Mashego's efforts to ensure that healthcare facilities in Limpopo adhere to the principles of Batho Pele, which prioritize the needs of the community.

Engaging directly with hospital management and staff, MEC Mashego said she aims to drive improvements in service delivery and promote a culture of accountability.

As the Limpopo Department of Health (LDoH) continues to work towards improving healthcare services, MEC Mashegosaidherleadership and commitment to quality care are crucial in driving positive change.

## Ga-Moretsele man sentenced to 30 years for brutal murder of girlfriend

GA-MORETSELE - On Thursday 04 September 2025, the Polokwane High Court has imposed a lengthy jail term on a 46-year-old man, Mpho Ephraim Phetla, who brutally murdered his girlfriend in Ga-Moretsele Village under the Jane Furse policing area.

Phetla was sentenced to 30 years imprisonment for murder and 3 years for theft, with both sentences running concurrently.

According to Colonel Malesela Ledwaba, Provincial Spokesperson of the Police in Limpopo, the incident occurred on 27 June 2024, when Phetla hacked his 43-year-old girlfriend to death with a sharp object following a heated argument.

"The victim who had sustained severe injuries on the upper body died instantly on the scene. The accused fled the scene with the victim's cellphone, but our detectives were able

**GA-MORETSELE** - On to track him down and arsday 04 September apprehend him," Ledwaba said.

He said members of Nebo and Jane Furse Tracking Team were alerted about the incident and they managed to trace Ephraim Phetla who was intending to flee to Gauteng Province and was apprehended while at his hideout in Maserumule Park Section on Saturday 29 June 2024 at about 01:00.

"He was found of the in possession deceased's cellphone. Sergeant Mogale Pilusa, attached Nebo Detectives, opposed bail, and Phetla was subsequently found guilty by the Polokwane High Court," explained Ledwaba.

Furthermore, ledwaba said the accused is still facing another murder case that was committed at Vosman Township in Witbank, Mpumalanga Province.

## Mob justice suspected in Driekop murder investigation

**THANKENG** - A gruesome discovery was made in the early hours of Sunday 7 September 2025, at Mooihoek, Thankeng Village, in the Driekop area, when the body of an unidentified man, believed to be in his thirties and suspected to be a Zimbabwean national, was found with severe multiple injuries.

According to Colonel Malesela Ledwaba, Provincial Police Spokesperson in Limpopo, preliminary investigations suggest that the victim was assaulted with stones and bottles, pointing towards a possible case of mob justice.

"The police responded to a report of murder at around 06:30 and found the victim dressed in blue jeans and a white T-shirt. Paramedics certified him dead on the scene. The motive for the incident is still under investigation," Ledwaba said.

Colonel Ledwaba reiterated the police's commitment to investigating the incident and bringing the perpetrators to

"The community is encouraged to work with the police to prevent such incidents and ensure that justice is served through the legal system," he said.

Ledwaba said the police are urging anyone with information that could assist in tracing the deceased's next of kin or lead to the arrest of the suspects to come forward.

Ledwaba encourages anyone who can assist in tracing the deceased's next of kin of assist in the arrests of the perpetrators to contact Detective Sergeant

Mmatlou Nkoana on 082 716 8075, Crime Stop Number on 08600 10111, the nearest police station, or the MySAPS App.

Mob justice incidents have been condemned by authorities in the past, highlighting the dangers of taking the law into one's own hands.

In a similar incident in August 2025, Lieutenant General Thembi Hadebe, Provincial Commissioner of the Police in Limpopo, emphasized the seriousness of mob justice, stating that it often results in loss of life and hampers legitimate police investigations.

Despite millions of rands being spent on the multipurpose sports centre, the facility is plagued by lack of maintenance and repairs, leaving it in a state of despair.

The neglect has sparked fears that the facility will end up being a "White Elephant", a symbol of poor planning and bad service delivery.

The Democratic Alliance (DA) in EPMLM has raised concerns about the state of the sporting facility.

DA Councillor in the municipality, Flip Jacobs, has been vocal about the municipality's failure to maintain the facility, citing poor planning and bad service delivery as the main contributors to its neglect.

"Our residents deserve better services," Jacobs emphasized, highlighting the need for accountability and transparency in municipal governance.

Jacobs indicated that it is more concerning that the Elandskraal Sports Facility, which was intended to be a hub for sports and community activities, is now at risk of becoming a rundown and potentially being repurposed as an animal shelter.

A resident, Khutso Malatji, said they are worried that lack of maintenance and repairs has resulted in the facility's

deterioration, making it difficult for athletes and community members to

"The facility's state is a far cry from its intended purpose, and its neglect has significant implications for the community," he said.

Malatji indicated that they are concerned that millions of rands spent on the facility have yielded little return, with the facility's condition worsening over time.

"The lack of maintenance and repairs has resulted in a significant waste of public funds, and the community is left to suffer the consequences. The municipality's failure to prioritize maintenance and repairs has led to a situation where the facility's future is uncertain," he said.

Malatji reiterated that the community is fed up and will embark in a call to action for the municipality to prioritize maintenance and repairs of the facility.

"The community deserves better services, and it is the municipality's responsibility to ensure that public facilities are well-maintained and functional. The fate of the Elandskraal Sports Facility hangs in the balance, and we want the municipality to commit and take the necessary steps to restore the facility to its intended glory," he said.

At the time of going to press, EPMLM Spokesperson, Nape Nchabeleng, could not respond to enquiries sent by the paper.


