

Two Dilokong Hospital doctors had been transferred after reporting for duty late.

- Two doctors at Dilokong Hospital were put on precautionary transfer due to allegations of professional misconduct.
- The doctors allegedly failed to report for duty on time, leaving patients unattended.
- **Critically ill patients** were diverted to **Meckelenburg Hospital** for emergency care.

Hospital have been put on precautionary transfer following allegations professional misconduct.

Their precautionary transfer pending an outcome of an investigation into the allegations. Percy Moagi, Limpopo Department of Health MEC's spokesperson, said the action follows an incident over last weekend when the two doctors failed to report for duty after 19h00, only arriving around 23h00, while they were officially scheduled to be on duty. Moagi pointed out that As a result, patients in casualty and various wards were left unattended, and the hospital had to urgently call in an off-duty doctor

"Critically ill and emergency obstetric

patients requiring surgery had to be doctors at Dilokong diverted to Meckelenburg Hospital for other patients their constitutional right emergency cesarean sections. In response, the hospital management immediately initiated a disciplinary action, and the two doctors were transferred to other facilities to allow for a fair and transparent investigation without compromising the hospital's operations," said Moagi.

Members of the surrounding community blocked the gates of Dilokong Hospital in protest, expressing support for the transferred doctors. "While the department understands community concerns, it strongly urges residents not to interfere with internal disciplinary processes," stated Moagi.

MEC Dieketseng Mashego has called on the local community to remain calm and to respect the internal processes underway.

"Blocking hospital entrances denies to access healthcare services. While we appreciate that community members may have built relationships with healthcare staff, protecting patient care and service delivery must remain the priority," said Mashego. The department has emphasized that disciplinary action is never taken lightly. The department stressed that when healthcare workers' conduct compromises patient care, swift and appropriate measures must be taken.

"When patients are denied services, communities demand accountabilityand rightly so. But when the department acts to hold individuals accountable for failing to deliver those services, we ask that communities support our efforts to protect healthcare delivery," concluded Mashego.

Operation Vala Umgodi makes strides against illegal sand miners

Six suspects, aged between 27 and 52, were on Friday 11 April 2025 arrested for illegal mining at Dikgalaopeng in the Motetema Policing area during the ongoing Operations Vala Umgodi.

Lieutenant Colonel Stephen Thakeng, Limpopo Provincial Police Spokesperson, said during the arrests, the police found the suspects busy mining sand illegally in the area without valid permit and they were then arrested.

Thakeng said the operations continued to other parts of the province, conducted between Tuesday 8 April 2025 and Thursday 10 April 2025, which led to the arrests of 36 suspects, aged between 20 and 52 for illegal mining of sand and contravention of immigration laws.

"In Capricorn District, five suspects, aged between 28 and 44, were arrested for illegal mining of sand at Nkumpi River in Mehlareng Village at Magatle Policing area. The members received information and swiftly responded, which led to the arrest of suspects and confiscation of trucks and other items. Whereas, in Mopani, 19 suspects, aged between 20 and 44, were detained for contravention of immigration laws in the Tzaneen, Letsitele, Makhado, Namakgale, Seshego Policing areas," explained

He added that in Vhembe, six suspects, aged between 28 and

48, were arrested separately at Tshilaphala Village in Vuwani and in Nwaxinyamani Village, Waterval Policing areas for illegal mining of sand.

He said the police also confiscated abandoned items at Mvudi River, Manini Village in Thohoyandou, during the disruptive operations.

"The suspects will soon appear before their local magistrate's court. Police investigations are continuing," Thakeng said.

According to Thakeng, during March 2025, 264 suspects were arrested for illegal mining activities and contravention of Immigration Act across the province.

"Amongst the arrested suspects, 31 were arrested for illegal mining offences and 212 for other offences related to illegal mining activities at Sekhukhune, Mopani, Vhembe, Waterberg, Capricorn, and Vhembe Districts. The operations were executed through patrols, stops, and searches at the illegal mining sites in the province, focusing on illegal mining activities and associated crimes," said Thakeng.

Provincial Commissioner of the Police in Limpopo, Lieutenant General Thembi Hadebe, has applauded the members of Operation Vala Umgodi across the province for stamping the authority of the state and ensuring that the minerals of this province are protected.

akhuduthamaga Local Municipality (MLM) councillors have on Thursday 10 April 2025, concluded a fourday Councillor's Policy Workshop, which began on Monday 7 April 2025. The workshop was set to discuss and refine council policies related to service delivery and issues affecting communities.

The session, organized and led by the MLM Council Speaker, Cllr Judy Nkgadima, served as capacity development for councillors, equipping them to deal with governance issues from an informed perspective, as well as policy and by-law formulating for the institution.

Among the policy items

received attention were the sports and recreation policy, arts and culture policy, Small, Medium and Micro Enterprises (SMME) and cooperative policy, Extended Public Works Programmes (EPWP) policy, various Information Technology (IT), risk management and budget policies. Council members were also refreshed on their role and responsibilities as public representatives, code of conduct for councillors, and their role in the public participation and ward governance reporting.

Experts from a variety government institutions participated in the event, including the Department of Cooperative Governance, Human Settlements and Traditional Affairs, the Department of Rural

Development, the Provincial Treasury, and the Sekhukhune District Municipality (SDM).

SDM Council Speaker, Cllr David Chego, addressed the session and stressed the necessity for councillors to actively engage in public participation programmes regularly to advance the primary objectives of a democratic government system.

In closing, MLM Mayor, Cllr Merah Mahlase, reminded councillors that "while we have a responsibility to provide basic services to our communities, we must also build a self-sustaining municipality by creating long-term revenue sources through billing of business property, essential services, social facilities, and other LED initiatives."

Man in custody charged with unlicensed firearm and ammunition

A 27-year-old suspect was on Thursday 10 April 2025 further charged for possession of unlicensed firearm and ammunition, the police said.

According to the police, the suspect was charged while in police custody for a different offense during an intelligence driven operation, which was executed in conjunction with Sekhukhune District Tracing and Investigation Team, focusing on suspects in possession of unlicensed firearms around Elandskraal policing area. Lieutenant Colonel Stephen Thakeng, Limpopo Provincial Police Spokesperson, said the 27-year-old male suspect was identified while in police custody following an arrest of assault case committed on Wednesday 2 April 2025 at Tsantsabela Village outside Marble Hall under Elandskraal policing precinct.

"The suspect was interrogated and admitted for being in possession of an unlicensed firearm that was allegedly concealed at his residence. The suspect led the police to his residence at Tsantsabela Village and a search was conducted. During the search, one unlicensed firearm with ammunition was found and he was immediately placed under arrest," explained Thakeng.

He said the suspect is expected to appear before the Marble Hall Magistrate Court soon facing a charge of possession of an unlicensed firearm and ammunition and the police investigations are continuing.

Ephraim Mogale Municipality warns of tender scam impersonation

The Ephraim Mogale Local Municipality (EPMLM) stated that they have noted with concern an unknown individual who impersonates the local municipality's Supply Chain official, with intentions of soliciting money from unsuspecting service providers, which the municipality says the act is a serious corruption and fraudulent activity.

The municipality has advised potential service providers to be alert of the scam, stating that when awarding contracts, they strictly follow official procurement processes.

"No quotation or tender can be awarded without a bid or quotation process being followed. All official quotations are advertised on the municipal website, notice boards and newspapers when applicable," said the municipality in a statement.

The municipality has requested service providers to not deposit any money into private bank accounts, adding that the Ephraim Mogale Municipality never charges a deposit in exchange of awarding a tender or order.

"No delivery of goods and services should be made without any official Purchase Order of the municipality. Ephraim Mogale Local Municipality condemns such illegal activities and encourages all service providers to stop entertaining such requests," the municipality said.

he Limpopo Department of Health has informed the public that the revised Uniform Patient Fee Schedule (UPFS) tariffs for the 2025/26 financial year officially came into effect on Monday 7 April 2025, in accordance with Treasury Authority No. 07/0005/2024/000T, implying that not all health services are free.

Health Department Spokesperson, Neil Shikwambana, said the department advice those who can afford to pay for healthcare service, whether partially or fully, that have a moral and civic responsibility to do so.

"The department uses an income-based billing system to decide how much you should pay for public healthcare services," he said. Shikwambana said the patients are grouped categorically and those who will be getting free healthcare are patients who are treated for certain conditions like communicable diseases such as TB, HIV/AIDS and others or meet the free healthcare criteria.

"The other group is the elderly people, those who are social grant recipients, disability grant recipients, those who get foster child grant, patient with mental disorders, veteran pensioners and children placed in orphanage facilities. The other group include children under the age of 6 years, pregnant and lactating women who are not covered by a medical aid scheme," informed Shikwambana. He added that all healthcare services are also free at primary healthcare facilities such as clinics, gateway clinics and community healthcare facilities.

Shikwambana said the other non-paying group includes low-income households that are greatly subsidised, mainly with a single income of up to R70 000 per year or R5 833 per month and a household income of up to R100 000 per year or R8 333 per month, greatly subsidised fees.

"The middle-income households that will be partially subsidised includes those with single income of between R7 001 and R250 000 per year or R5 833 to R20 833 per month. Household income of between R100 001 and R350 000 per year or R8 333 to R29 166 per month. They will pay partially subsidised fees. The subsidy applies only to those who are not funded by medical schemes/insurances, paid for by employers or any other funder," explained Shikwambana.

He furthered said the fully paying patients will be those with high income which includes single person earning more than R250 000 per year which is over R20 833 per month. Household income of more than R350 000 per year which is over R29 166 per month. They will be paying full cost of service with no subsidies.

"Also, 100 percent charges shall apply for certain services regardless of income or category, all patients will be required to pay full fees for cosmetic surgery, medical records, emergency standby facility fees and other services listed in the UPFS 2025/2026 schedule," stated Shikwambana.

Furthermore, Shikwambana said the Limpopo Department of Health reminds all residents that not all healthcare services are free.

"The updated patient fee schedule ensures that those who can afford to pay do so, allowing the department to subsidise care for the poor and keep essential services running. This is a shared responsibility rooted in dignity, equity, and ubuntu. By paying your share, you are helping someone who cannot. This revision is a necessary step to keep the public healthcare system sustainable, fair, and accessible for the most vulnerable in our communities," he said.

EFF marches to demand improved government services

ozens of Economic Freedom Fighter (EFF) members in Elias Motsoaledi Local Municipality (EMLM) Sub-Region, have on Thursday 10 April 2025 embarked on a peaceful protest to deliver memorandums to the Department of Labour and the Department of Home Affairs in Groblersdal, outlining their concerns and proposed solutions.

The protest, which started at the Labour Department before proceeding to the Department of Home Affairs, was leaded by Provincial Secretary of EFF in Limpopo, Kgothatso Mogoane and member of Provincial Command Team Walter Molapo.

They delivered a memorandum of demands, highlighting issues related to employment and workers' rights such as high levels of unemployment, limited access to skills development programmes, severe shortage of labour inspectors, poor UIF registration and pay-outs, weak enforcement of compensation fund registration, dysfunctional CCMA services, exploitation of foreign and informal workers, lack of workplace safety monitoring and lack of public employment programmes.

Key demands included investigation of employers who do not comply with labour laws, poor working conditions in all the farms around Groblersdal, an effective role play by the department to ensure fair labour practices to protect rights of farm workers, intensified regulatory mandate of inspections, investigation of racially motivated cases in the farms, establishment of a dedicated office to specially address the issues of seasonal farm workers in Groblersdal and abolishment of labour brokers in the farms and in the retail industry.

The party furthered demanded the labour office to investigate all Injury on duty cases in the farms, an investigation on cases of victims of farm pesticides, a probe on human rights violations in the farms, action be taken against companies which are deducting money from the salaries of security guards, farm workers and retail workers on the basis that the money will be contributed to workers' pension funds and provident fund, which in actual fact, they do not contribute.

They also demanded that security companies be investigated for non-compliance with the Pension Funds Act, in relation to health and provident fund contributions.

They also submitted a memorandum at the Department of Home Affairs complaining about lack of access to services in rural and remote areas, inadequate school outreach programmes, delays in ID and passport processing, department's failure to register all immigrants, poor infrastructure and equipment.

They were also concerned about the department being understaffed, long unattended queues, unemployment of skilled graduates, and the unavailability of home-based services for people with disabilities, corruption and bribery at local offices.

They were demanding the Home Affairs to upgrade its systems, stating that they are forever offline thereby, disadvantaging poor people who travel long distances to reach the Groblersdal office.

They also demanded the department to make an immediate intervention to address the problems of power failures and lack of proper equipment.

The party demanded the department to urgently investigate the allegations of corruption by officials who demand bribes to fast-track applications.

EFF Party Whip in EMLM Sub-Region, Ali Maloba, expressed frustrations with the current state of affairs of the affected departments, emphasizing the need for swift actions to address the community concerns.

"It is concerning because on arrival at the Department of Labour, we were welcomed by seasonal workers' and UIF applicants' long queues. It has become evident that the department itself doesn't have a permanent solution in addressing the problem," he said.

Maloba said they protested to call on both departments to improve their services and responsiveness to the public's needs.

Representatives from both departments received the memorandums and acknowledged the EFF's concerns, stating that they will review the issue raised and work towards implementing necessary changes.
