Two lost lives in separate domestic High Density Operation related violence incidents



Provincial Commissioner of the Police in Limpopo, Lieutenant General Thembi Hadebe, has advised that anyone who might experience domestic related problems to seek professional help.

The Provincial Commissioner of the Police in Limpopo, Lieutenant General Thembi Hadebe, has strongly condemned the domestic violence-related and gender-based violence incidents, following recent incidents that took place at Sekhukhune and Capricorn Districts on Friday 14 March 2025.

Colonel Malesela Ledwaba, Limpopo Provincial Police Spokesperson, said in one of the incidents, occurred on Friday 14 March 2025 at around 23:00 at Malegale Village in Sekhukhune District, the suspect was searching for a male victim who allegedly bought bricks from his brickyard.

"The suspect, who was driving his own vehicle, met the victim on the street in his vehicle and without saying any words, he shot him on his upper body. The victim managed to drive to the nearest hospital and fortunately survived," said Ledwaba.

He added that following the shooting the suspect went back to his own house and on arrival, he allegedly poured a flammable liquid on his house and set it

"He proceeded to another room where his wife was sleeping and woke her up, threatened to kill her, and instructed her to get inside the burning house with him. Fortunately, the wife managed to escape and the suspect tried to chase and shoot her several times with no luck. Later, the suspect shot himself and died on scene," explained Ledwaba.

He said the police have opened an inquest docket and is under investigation.

Ledwaba said in another incident occurred in Mankweng, a 48-year-old male suspect was apprehended for the brutal murder of his 14-year-old stepdaughter at Ga-Thoka Village within the Mankweng policing precinct in Capricorn District on Friday 14 March 2025, at around 06:30 in the morning.

"According to the report, the victim was on her way to school, accompanied by her fellow learner, when the stepfather approached, attacked, and stabbed her several times with a sharp object and left her helplessly on the road," Ledwaba said.

He said the police were informed about the attack and on their arrival, they found the victim lying in a pool of blood, still wearing a well-known school uniform.

medical "The emergency service personnel summoned and upon their arrival, the victim was certified dead on the scene. The police activated a search operation for the suspect immediately and he was located in Polokwane where he was apprehended," said Ledwaba.

He added that preliminary police investigations revealed that the suspect had a domestic dispute with the deceased's mother the previous night.

"The suspect will appear before Mankweng Magistrate's Court soon, facing charges of murder," said Ledwaba.

He said the police urge anyone who is experiencing any gender-based violence related or domestic violence related matter to seek assistance from the professionals.

Ledwaba said the police are continuing with investigations on both cases.

Kakula nets 949 suspects

The Limpopo Provincial Police High Density Operation Kakula (Shanela), conducted throughout the province from Monday 10 March 2025 until Sunday 16 March 2025, led to the arrests of 949 suspects for various criminal offenses.

The operation comprises of various police units including South African National Defence Forces (SANDF), Traffic Police and the Community Police Forum

Lieutenant Colonel Stephen Thakeng, Limpopo Provincial Police Spokesperson, said the suspects who were arrested during the operation were charged with offenses including robbery, armed murder, attempted murder, car hijacking, illegal mining, contravention of illegal immigrants and illegal possession of firearms.

"The operation was executed through high-visibility patrols, vehicle checkpoints, stop and search, tracing of wanted suspects and compliance with inspection of scrap yards," he said.

operation, the law enforcement agencies arrested 11 suspects for

possession of unlicensed firearm, fourteen suspects were nabbed for possession of dangerous weapons, 42 other suspects arrested for malicious damage to property, six nabbed for illegal dealing in liquor, two suspects arrested for car-hijacking and two more suspects arrested for armed robbery.


He furthered said eight other suspects were arrested for business robbery, 14 for robbery suspected in residential area, four nabbed for murder, 19 arrested for attempted rape and 99 suspects arrested for assault with intent to commit grievous bodily harm (GBH).

"During the operation the police also recovered 380.56 ml alcohol beverage 29,347kg of dagga drugs and R30,266-00 amount of cash. The arrested suspects have already started to appear in various magistrate's courts,"Thakeng said.

Villagers Ga-Mabintane within Makhuduthamaga Local Municipality (MLM), have in the early hours of Monday 17 March 2025, woken up to a gruesome discovery of a dead body floating in the Motsephiri River. The discovery of the body was made by local villagers who were crossing the river to get wood from the nearest bushes. The deceased was later identified as Frank Phetla, a professional nurse stationed at Jane Furse Hospital who was residing at Jane Furse Zamani Section. The victim's body was discovered a day after his kidnapping. A case

about his kidnapping and disappearance was reported at the Jane Furse Police Station on Sunday 16 March 2025.

MLM Mayor, Cllr Merah Mahlase, and her council collectively sent sincere condolences and sympathies with the bereaved family during this difficult period of grief.

According to the police reports, an inquest case has been opened at the Hlogotlou Police Station to investigate the circumstances surrounding the gruesome death.

This is the second lifeless body to be discovered in the Motsephiri River in a period of about a year. On 13 March 2024, a man's body was found near the same river stream.

The Makhuduthamaga Municipality said they will send a delegation to the Phetla family to offer support and condolences. Mayor Mahlase has called upon the police to speed up their investigations arrest everyone who participated in the deceased's kidnapping and murder to send a strong message to the perpetrators of crimes. The mayor stressed that: "No one is above the law, and everyone involved must eventually pay for their inhumane actions."

the municipality's commitment to responsible financial management and accountability.



"The underspending infrastructure projects is a result of poor planning, weak monitoring and implementing agents that cannot complete projects

within schedule and is and an indictment of the department's misgovernance. The department also surrendered a further R112 million of their operational funds amid infrastructure challenges in Limpopo and this raises concerns on the effect it will have on the mandate of the department and its programmes. The LDoE received an additional R86.388 million for infrastructure damaged by floods and MEC Lerule-Ramakhanya must ensure it is utilised efficiently and avoid unwanted expenditure," added

He said it is unacceptable department loses infrastructure grant funding while Limpopo learners are exposed to learning under trees, overcrowding, dilapidated buildings and severe shortage of

"The department needs to ensure there is greater monitoring over implementing agents and improved project management to ensure that infrastructure projects are of a satisfactory standard, are done on time and within the allocated budget. The DA will monitor expenditure of the disaster management funds to ensure it is spent in accordance with the legislative framework," concluded Smalle.

Health, Dieketseng Mashego embarked on a TB awareness programme at Tshehlwaneng Taxi Rank and Morena Complex in Jane Furse, Makhuduthamaga Local Municipality (MLM) on Monday.

Neil Shikwambana, Limpopo Department of Health (LDoH) spokesperson, said the TB bliss was part of educational build-up activities for this year's Provincial World TB Day to be held at the Peter Nchabeleng Sports Ground in Schoonoord on 20 March (today).

MEC Mashego urged members of the community to visit nearby health facilities for TB screening. She pleaded, "Everyone present here needs to make it a habit to visit health facilities to screen for TB and other diseases."

MLM Mayor, Merah Mahlase joined the MEC during the drive. They both interacted with community members, sending out messages and issuing pamphlets to encourage testing for TB and other diseases using the health facilities in their respective areas.

Members of the public are advised to always cover their mouths and nose when sneezing or coughing, cough into a tissue or inside their elbows, throw away all used tissues into the dustbin and always open windows and doors at home and crowded rooms, churches, taxis et cetera.

The bliss took place just days after the MEC met HIV/ Aids strategic stakeholders on 13 March to collaborate programmes in relation to closing the 1.1 million gap campaign.

The 1.1 million gap are people who know their statuses but not on treatment. They either don't want to take treatment or were on treatment but defaulted.

The purpose of the meeting was to reduce the prevalence of HIV/Aids and collaborate with LDoH to close the 180 thousand gap of those who either defaulted or don't want to take treatment.

DA Limpopo pledges to monitor flood relief funds

SEKHUKHUNE Democratic Alliance (DA) in Limpopo has vowed to monitor flood relief funds to ensure accountability in the province.

The DA said it has noted the declaration of flood-affected areas in Limpopo and other parts of the country as a national disaster following the severe flooding in February.

Lindy Wilson, DA Provincial spokesperson for disaster management, indicated that the party will closely monitor the application of relief funds to ensure they are used transparently and effectively, safeguarding against misappropriation.

Thabazimbi remains one of the hardest-hit regions in Limpopo. The DA has since called for the declaration of Sate of Disaster.

"This was to expedite resource mobilization, enhance interdepartmental coordination and streamline government's response to the extensive damage to property, infrastructure and essential service delivery including the farming sector," explained Wilson.

Under the Disaster Management Act, national government and provincial executives are required to implement a multisectoral rehabilitation plan to address the effects of the disaster.

Wilson said additionally, each organ of state is required to submit progress reports to ensure

transparency and accountability.

"The DA in Limpopo will ensure that the newly established Limpopo Portfolio Committee on Disaster Management exercises its mandate and ensures that the rehabilitation efforts result in a swift and full recovery for the affected communities.

Action SA pushes for completion of abandoned Mogorwane Pedestrian Bridge

Action SA political party in Sekhukhune District Municipality (SDM) has called for urgent intervention after a pedestrian bridge project, which was meant for school children at Mogorwane Village, was allegedly abandoned by the contractor.

According to the party, the construction of the bridge started in November following an enthusiastic plea made by local residents to ensure safety of school children who are crossing dangerous flooding areas on their way to school. The pedestrian bridge in Makhuduthamaga Local Municipality (MLM) Ward 10, was set to be completed in January 2025 before the school's reopening day.

Tonic Manchidi, Action SA Chairperson in Sekhukhune Region, said in September 2024, MLM committed to construct the bridge as an intervention to ensure that scholars from Mapogo Primary and Mawuane Secondary Schools, who navigate unsafe conditions, cross safely when going and returning from school.

"The municipality assured residents that the bridge will be completed before schools resumed. However, this promise has been broken, and the project has been abandoned without explanation," said Manchidi.

He added that the situation concerning because every day parents are forced to cross the hazardous area with their children, fearing for their safety.

"This situation is unacceptable and poses a severe risk to the lives of innocent children who deserve safe access to education. It is alleged that funds allocated for this critical infrastructure project have already been misappropriated by corrupt individuals within the municipality. If true, this represents not only a betrayal of public trust but also a direct threat to the well-being of our community," explained Manchidi.

He insisted that the party will not stand idle while the communities are neglected and endangered.

"We call upon Makhuduthamaga Local Municipality to urgently address this issue and provide clarity on why the project has stalled," Manchidi said.

He indicated that Action SA will escalate the matter by reporting the municipality to the office of the Public Protector for immediate investigation into allegations of corruption and misuse of public funds.

"The safety of our children cannot be compromised. We demand swift action from all relevant authorities to ensure that this bridge is completed without further delay and that those responsible for any wrongdoing are held accountable," said Manchidi.

At the time of going to press, MLM Spokesperson, Thomas Mashabela, could not respond to the enquiries sent by the publication.

"I started by drawing cartoons such as the famous Dragon BallZ animations and sell them R2 per sketch to fellow learners. I was making quiet a fortune as a primary school learner because those cartoons where mostly every child's favourite by that time. I would even share my profits with my siblings. Sometimes I would even draw while I was expected to write my school work that was the only time I would get into trouble with teachers," he said.

Vusimuzi says he stopped his drawing passion when moving into high school because of adolescent stage, and he would only draw when it is necessary especially when he has being asked by someone who knows he is very good with drawings.

"I once had a wedding

dress to decorate with Ndebele colours. It was for the first time and I was so scared. A wedding is a big ceremony I was so surprised that this person is trusting me with her big day atier, but I had to deliver. Thank God she still wears the dress even today. When she is attending weddings, she would take pictures and send them to me," remarks Vusimuzi.

He says after completing high school and not having any luck of finding a job, he returned to his artistic journey to chase his childhood dream where he re-developed expressive power of drawing and paintings.

"I then started my drawings at home simply of my family portraits, they would like the pictures and I would sell them. Then something just reminded me of those R2s I used to make in primary school. I then did some self-introspection then drawing was again my answer. I started trying new things like painting and re-doing old shoes. People did show interest. Since then I never looked back and started exploring new drawing styles and techniques," adds Vusimuzi.


Vusimuzi says he believes that he was born for art as he was not an academically gifted person.
