

esidents of Laersdrift, a community under the Elias Motsoaledi Local Municipality (EMLM) Ward 30, stated that they are facing a harsh reality of not getting clean drinkable water.

Residents say despite celebrating Nelson Mandela's legacy and his fight for equality and access to basic services, they are struggling to access one of the most fundamental human rights, clean drinking water.

According to residents, the Larsdrift community is experiencing a serious shortage of drinking water, forcing them to share water with animals from nearby rivers and streams. This situation is not only unhygienic but also poses serious health risks to the community.

"We are living in a country that prides itself on its rich history of fighting for human rights, yet we are struggling to access something as basic as clean drinking water," said a frustrated resident who did not want to be named. "It is unacceptable that we are forced to share water with animals, it is a situation that no human being should endure," she said.

The situation is unhygienic and poses serious health risks.

The resident indicated that the community's plight is a stark contrast to the values of equality, dignity, and access to basic services that Nelson Mandela fought for.

"As the nation celebrates Mandela's legacy, the residents of Laersdrift are reminded of the long road to achieving these fundamental rights," she said.

She added that the affected community will be urging authorities to take immediate action to address the water shortage crisis and provide the community with access to clean and safe drinking water.

"We are calling on the authorities to prioritize our plight and provide a lasting solution to the water shortage. We urge the municipality to take immediate action to address the situation and ensure that we have access to clean and safe drinking water. Until then, the residents of Laersdrift will continue to face this daily struggle, a stark reminder of the work still to be done in ensuring that all South Africans have access to basic human rights," she said.

.Sekhukhune District Municipality (SDM) Spokesperson, Lemson Moropjane, said they are aware of the water shortage in Laersdrift, adding that the district municipality is developing underground water sources to mitigate the challenge.

"The root cause of the water shortage, however, is the location of the village. The settlement has no formal infrastructure for bulk services. Our long term plan is to draw bulk water from de-hoop," he said.

Moropjane indicated that in the interim, and as an emergency measure, the municipality has implemented a water borehole system, with two boreholes been installed and are functional.

Five suspects arrested in connection with kidnapping of Ugandan woman

ATOK - A dramatic rescue operation was carried out by the Limpopo Provincial Organised Crime Unit, leading to the arrest of five suspects linked to the kidnapping of a 42-year-old Ugandan national woman.

According to Colonel Malesela Ledwaba, Limpopo Provincial Police Spokesperson, the incident occurred on Tuesday 15 July 2025, at approximately 10:00, when the victim was travelling through

"She was accosted by a group of male and female suspects driving a Toyota Hilux double cab with no registration plates. The suspects allegedly threatened her at gunpoint, forced their way into her vehicle, and drove her to a house in the Mecklenburg policing area, where she was severely assaulted and tortured," explained Ledwaba.

He said the suspects later contacted the victim's relative and demanded a substantial ransom for her release.

"The police were alerted on Thursday, and a multidisciplinary task team was immediately established. In the early hours of Friday 18 July 2025, the suspects instructed that the ransom be delivered at Apel Shopping Mall. The team tactically intercepted

He indicated that all five suspects were arrested, and the victim was rescued unharmed.

"During the arrest, the police recovered a firearm with ammunition, cellphones, and the victim's bank card. The five suspects, three women and two men aged between 25 and 36, are all South African citizens. They have been charged with kidnapping, attempted murder, and possession of an unlicensed Ledwaba said.

He said the suspects are expected to appear before the Sekhukhune Magistrate's Court

The Provincial Commissioner of the Police in Limpopo, Lieutenant General Thembi Hadebe, praised the swift and effective action by the team.

"We commend the team for their swift and strategic response. This case sends a clear message that such violent and criminal acts will not be tolerated and will be dealt with decisively," said

Dr Magana, in collaboration with the ward councillor and community development worker, identified her family for assistance due to their dire circumstances. During the handover event, Dr Magana shared his personal story of humble beginnings, highlighting the importance

of providing stable housing for those in need.

"I understand the feelings of families who lack a proper shelter. This is the main reason we decided to start the Dr Magana Foundation," he stated.

"The initiative is a testament to the power of community involvement and the importance of supporting one another. It serves as a reminder that we all have a role to play in building a future for those who are less fortunate" he said.

Addressing the hand-dover event, Mayor Tladi emphasized the spirit of Ubuntu, stating: "Let us all be involved in changing other people's lives. What we did today is a sign of Ubuntu. We are not merely handing over houses; we are restoring dignity and creating a legacy for generations to come."

Tladi indicated that the

municipality worked closely with local businesses, which made generous donations to support the project.

SEKHUKHUNE - A high-impact, intelligence-driven operation dubbed "Ops Knock Knock", has led to the arrest of two suspects linked to a series of house robberies in the Sekhukhune

by members of Burgersfort Detectives, Sekhukhune District Task Team, and Public Order Policing (POP) between Friday 18 July and Saturday 19 July 2025.

Colonel Malesela Ledwaba, Limpopo Provincial Police Spokesperson, said the suspects, aged 32 and 41, were arrested after a high-speed chase and a night-long manhunt.

"The 32-year-old suspect, originally from Daveyton, Gauteng, was arrested on Sunday morning, 20 July 2025, at 06:00, while the 41-year-old suspect was apprehended later in a nearby village. The police seized a red Dodge Chrysler, three cellphones,

and a 9mm pistol with an empty magazine. The suspects have been positively linked to at least three house robberies committed in Apel in February and July 2025," explained Ledwaba.

He added that the third The operation was conducted suspect, considered the most dangerous and allegedly in possession of a firearm, is still at large, and efforts to trace him are ongoing.

> "The arrested suspects will face charges of attempted murder, possession of an unlicensed firearm, and multiple counts of house robbery. The suspects are expected to appear before the respective Magistrate's courts soon," Ledwaba said.

> Ledwaba said the police commends the efforts of the members involved in the operation and urges the public to continue providing valuable information to assist in the fight against crime.

Ramathuba lauds PICC for successful 2025 Initiation Season



The 2025 Initiation Season has finally came to an end in Limpopo, with over 25 000 young men and women graduating across

Limpopo Premier Dr Phophi Ramathuba hails the Provincial Initiation Coordinating Committee(PICC), senior traditional leaders, and stakeholders for their diligent efforts in managing the 2025 initiation season, which has officially come to a close last weekend.

Under the guidance of the Customary Initiation Act, 2021, the Limpopo Provincial Government, in collaboration with traditional leadership structures, successfully facilitated the safe initiation of over 25 000 initiates across the province.

A total of 500 registered initiation schools operated during the season, comprising of 350 male and 150 female schools.

While a few illegal schools were identified, swift interventions by

law enforcement and traditional leaders helped mitigate their

Premier Ramathuba noted that although the majority of schools conducted their activities with discipline, cultural integrity, and adherence to safety protocols, the province regrets the tragic loss of two young initiates.

"We mourn the loss of two young lives and extend our deepest condolences to their families. One death is one too many. As government, together with our traditional leaders, we remain resolute in our mission to ensure that no life is lost during initiation. We will continue to strengthen health screening protocols and intensify monitoring mechanisms to prevent such tragedies in the future," said Ramathuba.

Premier furthered commended the cooperation of traditional leaders and initiation school principals who complied with the regulatory framework, submitted applications on time, and upheld cultural standards while prioritizing the health and safety of initiates.

She urged those intending to open initiation schools in the future to ensure early registration and compliance with relevant legal provisions.

Ramathuba said the Limpopo Provincial Government remains committed to working closely with traditional leaders and communities to build on the progress made this season and ensure an even safer, wellcoordinated initiation process in the years ahead.

Off-duty police officer foils armed robbery, suspect fatally shot

GA-MASHA - An off-duty members mobilized and despite police officer foiled an armed robbery and fatally wounded the suspect, dramatic incident unfolded in the early hours of Saturday 19 July 2025, at Ga-Masha Village.

According Colonel Malesela Ledwaba, Limpopo Provincial Police Spokesperson, police preliminary investigations revealed that a female cashier was accosted by an armed suspect as she walked to her rented backroom after closing a local pub.

"The suspect robbed her of an undisclosed amount of money at gunpoint. However, the victim's screams alerted the nearby off-duty police officer, who confronted the armed suspect. A shootout ensued, and the suspect was fatally wounded. He was found in possession of an unlicensed firearm and ammunition," said Ledwaba.

He added that in a shocking turn of events, community

police intervention, torched and looted the business premises where the robbery occurred.

"The police managed to disperse the crowd, but the building was completely destroyed. A case of arson has been opened, and a manhunt has been launched for the suspects involved in the destruction of property. The police are urging anyone with information that can assist in the investigation to come forward. Lieutenant General Thembi Hadebe, Provincial Commissioner of the Police in Limpopo, has commended the bravery of the off-duty police officer who acted selflessly to protect a life.

condemned the destruction of property, stating that such actions undermine the rule of law and will not be tolerated.

"We commend the bravery of our member who acted selflessly to protect a life, but we strongly condemn the criminal conduct of torching and looting. Such actions undermine the rule of law and will not be tolerated," said Hadebe.

Praktiseer Mountain Square, the latest community to be electrified





The mayor of Fetakgomo Tubatse Local Municipality his worship Cllr Eddie Maila has handed over a contractor for the electrification of Mountain Square, this village is in Praktiseer Ward 30. The contractor was introduced to the excited community members on July 18

Maila was accompanied by Head of Infrastructure Development and Technical Services Cllr Halinda Mojalefa, Head of Budget and Treasury Cllr Queen Moeng, Head of Local Economic Development and Tourism Cllr Morashiya Mabelane, Deputy Head of LED & Cllr Thabo Makofane, Deputy Head of Budget and Treasury Cllr Juliet Mabelane and Ward 30 Councilor Cllr Sarah Magabe.

More than 300 community members from Ward 30 and surroundings attend the event. The project will be implemented over a period of 8 months where 1900 households are to be electrified.

The mayor indicated that the responsibility of the Project Steering Committee (PSC) is to monitor the project and ensure its smooth operation. They must

stick to their responsibilities and desist from disturbing the work flow. "We are sick and tired of individuals collapsing service delivery projects. Gone are the days where we will allow people to disrupt our work in our communities. I put my neck on the block, I will be involved in this projects every step of the way to ensure no one disrupts it," Maila said. Maila pleaded for the cooperation and support of the community to the contractor to implement the project until its completion. Maila reminded the contractors about their objective in the village. He warned them that the municipality is expecting quality projects that must be implemented within the stipulated time. "Contractors must ensure that the locals benefit in terms of employment business opportunities through the correct procedures." He committed to completing the project on time, as it will benefit economic activities in Praktiseer. Community members applauded the municipality for fulfilling its commitment to electrify the settlement and further committed to safeguard the project until its completion.

A harrowing accident occurred on Saturday 12 July 2025, along the R25 Road between Dennilton and Groblersdal, leaving a minibus taxi severely damaged and sparking concerns about the road's deplorable state.

Herbert Radingoana, the owner of the affected minibus taxi, shared his account of the incident, highlighting the potential consequences of neglecting the road's

According to Radingoana, the accident involved his Toyota Quantum, a Corsa bakkie, and a Mercedes Benz.

The Quantum, which was carrying 15 passengers from Johannesburg to Groblersdal, who were on their way from buying goods and other essentials for shops and street vendors, was struck by the Corsa bakkie after it lost control while navigating the road's poor conditions.

"The accident clearly occurred due to the narrowing of the road and bad road conditions. A Corsa bakkie lost control because of the bad road and drove into the opposite direction that's when it collided with my taxi and the other vehicle," he said.

Fortunately, all 15 passengers escaped

without injuries, however, the minibus taxi was written off due to heavy damage.

Radingoana attributed the fortunate outcome to his driver's skill, stating that "if my driver wasn't perfect, 15 lives of innocent community members would have perished. Thanks be to God that no one had injuries in the horrible accident."

The accident has brought attention to the dire state of the R25 Road, which has been a subject for concern for motorists

Radingoana expressed his frustration with the authorities' apparent neglect of the road, stating that "the Limpopo Province is failing us as business persons because our bread is on the commuters that we are transporting. So if our vehicles are now like living coffins, it's hard for us."

Tendani Munyai, Spokesperson for Department of Public Works, Roads and Infrastructure in Limpopo, said regarding the current state of the R25 Road, the department's MEC has pronounced in his budget speech for the 2025/2026 financial year that the road is among 69 others planned for rehabilitation in the current

SARTHO pleads for leniency with initiation schools

SEKHUKHUNE

The South African Religious and Traditional Healers Organization (SARTHO) has pleaded with the Provincial Initiation Coordinating Committee (PICC) to be lenient with initiation schools that failed to meet the set date in line with their permit.

Some schools were forced to close on Sunday 20 July to avoid penalties and losing their permit due to challenges faced by parents who were unable to pay the balance of the initiation fee.

According to Mamokwa Hlabirwa Walker, SARTHO's Secretary General, most initiation schools failed to honour the set date due to challenges beyond their

"We would like to plead with PICC and COGHSTA to deal with such cases in consideration with the fact that parents are stakeholders," he said.

Walker added that they learned that some of the parents were forced to turn to loan sharks to pay for initiation fees, and they are expecting to pay the balance after

receiving their salaries on 25 July 2025.

Dr Shimanki Lion Bapela, Principal of Ditau Tsa Mariri Koma Association, shared his experience, saying: "I was forced to release some of the children whose parents were not ready to receive them, some parents pleaded with me to bear with them until the 25 July 2025 to get their salaries."

SARTHO believes that the authority concerned, especially PICC, should consider all factors that led to some schools breaching the terms of their permits.

Dr Ratholo Phahlane, Chairperson of SARTHO, emphasized the importance of involving all stakeholders, especially parents or guardians who are financially responsible for the tuition and other things needed during the initiation period.

"The organization hopes that the PICC will handle each case separately and consider the challenges faced by schools in the province. SARTHO believes that monitors will be of assistance in assessing the situation and finding a solution that works for all parties involved," he said.



SARTHO members pleaded with the PICC to be lenient with initiation schools that could not meet the set deadline of permits.


