

Leopard sightings in Motetema, residents urged to exercise caution



The EMLM is advising the public to remain vigilant following the leopard sightings in Motetema mountains.

MOTETEMA

esidents in Motetema and surroundings of Elias Motsoaledi Local Municipality (EMLM), are advised to remain vigilant and take necessary precautions to ensure their safety, following sightings of a leopard in the vicinity of the area.

According to Simon Makua, EMLM Spokesperson, the leopard was first spotted in the vicinity of the Motetema mountains on Sunday 21 September 2025.

He assured residents that the local municipality is taking the situation seriously and is working closely with relevant authorities to track the animal and ensure public safety.

"The safety of our residents remains our top priority. We urge community members not to approach the leopard under any circumstances," he said.

Makua indicated that the municipality, in collaboration with the professional wildlife rangers and experienced tracking teams, have been deployed to monitor and capture the leopard.

"Humane and safe methods are being used to ensure the animal is removed without harm. To safeguard residents, joint patrols with community safety structures are underway, with special attention to high-risk areas. Community members are urged to avoid bushy or isolated areas, especially at night, and to keep children and livestock indoors and secured at all times," cautioned Makua.

He added that authorities have already identified possible movement zones of the leopard and while the animal has not yet been captured, progress is being made as reported sightings are immediately followed up by the tracking teams.

"The situation remains under strict monitoring until the leopard is secured. The municipality is also intensifying awareness efforts beyond Facebook. Updates and safety guidelines are being communicated through loud-hailing in affected villages, local radio stations, community WhatsApp groups, direct communication via ward councillors and community development workers," informed Makua.



Cable theft, a blow to EMLM infrastructure



EMLM says prevalent acts of cable theft are crippling the municipality infrastructure and affect service delivery. The municipality is calling on the public to come forward and report perpetrators

According to Elias Motsoaledi Local Municipality (EMLM), cable theft incidents, which are prevalent in the municipality recently, severely cripple the municipal infrastructure by damaging critical equipment, interrupting electricity supply and largely affect service deliver to the

In a latest incident, a cable theft has occurred at one of the municipality's minisubstations in Groblersdal, resulting in an unexpected power outage that has affected several customers, including B3 Funerals, Martins Funerals, and surrounding

The municipality's technical team has been dispatched to the scene and diligently restored power supply as quickly as possible.

According to Simon Makua EMLM Spokesperson, the consequences of cable theft go beyond just disrupting daily business operations.

"It also affects the delivery of essential



services such as water supply, sanitation, street lighting, traffic signals, and safety services," he added. Makua indicated that the municipality

has condemned this act of vandalism and is appealing to the community to assist by reporting any suspicious activities related to cable theft.

"The cost of repairs will divert funds away from other planned community development projects, further harming service delivery. The municipality apologizes for the inconvenience caused and appreciates the patience and understanding of all affected customers,"

Makua urged residents to be vigilant and report any information that could lead to the apprehension of those responsible for the theft to relevant authorities.

"Residents are urged to report any information that could lead to the apprehension of those responsible for the theft," he said.



Sekhukhune District breathes a sigh of relief as neighbours reel in drunk driving crackdown

SEKHUKHUNE

In a weekend blitz that saw 17 motorists across Limpopo arrested for drunk driving, Sekhukhune District Municipality (SDM) stood out as a beacon of responsibility, with zero incidents reported.

The Phuza Weekend Operation, conducted by the Limpopo Department of Transport and Community Safety from Wednesday 17 and Friday 19 September 2025, aimed to intensify the fight against drunk driving and promote road safety.

According to the department's spokesperson, Ms Tidimalo Chuene, the operation resulted in a significant number of arrests, with Vhembe District recording the highest number of offenders, at eight drivers taken off the road.

"In the Capricorn District, three motorists were arrested, with the highest alcohol reading recorded at 0.93mg/1000ml. Mopani District accounted for two arrests, the highest reading being 0.30mg/1000ml. Vhembe District registered the highest number of arrests, with eight drivers taken off the road. The most severe case recorded was 0.60mg/1000ml. Waterberg District recorded four arrests, with the highest reading at 0.88mg/1000ml. Sekhukhune District reported no incidents of drunk driving during this period," explained Chuene.

She added that the department's zerotolerance stance on drunk driving is clear, and these arrests serve as a stark reminder of the dangers of driving under the

"The decisions you make behind the wheel determine whether lives are saved or lost," she said.

In related news, road safety experts have praised the department's efforts, citing statistics that show drunk driving is a leading cause of road accidents in South

According to Arrive Alive, a road safety initiative, drunk driving is a major contributor to fatal crashes, with many accidents involving drivers who have exceeded the legal blood alcohol limit.

As the festive season approaches, road safety authorities are expected to intensify their efforts to prevent accidents and promote responsible driving.

The Limpopo Department of Transport and Community Safety's Phuza Weekend Operation is a step in the right direction, and Sekhukhune District's exemplary record serves as a model for other districts to follow.

Rapid action by Groblersdal Farm Watch leads to arrest of rape suspect



A suspect was apprehended by Groblersdal Farm Watch members and later handed-over to the police after raping a 22-year-old woman along the R33 Road outside Groblersdal.

ordeal came to an end on Monday 22 September 2025, when a suspect accused of raping her was arrested along the R33 Road in the Groblersdal policing precinct.

The swift action by Groblersdal Farm Watch members and the police led to the apprehension of the suspect, who allegedly drove the victim from Motetema policing area towards Groblersdal before committing the heinous crime.

According to Brigadier Hlulani Mashaba, Limpopo Provincial Police Spokesperson, police preliminary investigations revealed that during the incidents, the suspect's vehicle ran out of fuel and got stuck on a farm section of the R33 Road, where he took advantage of the situation to rape the

LDoH provides update on acid attack survivor, Mampeu Hlanga

The Limpopo MEC for Department of Health (LDoH), Dieketseng Mashego, has on Tuesday 23 September 2025, expressed deep concern and continued support for Mampeu Neo Hlanga, a 27-year-old woman from Sekgweng Village in Zebediela, who survived a horrific acid attack in October 2024.

The attack, allegedly carried out by a 25-year-old woman who accused Hlanga of being romantically involved with her boyfriend, left her with severe burns on her face and body, requiring extensive plastic

Hlanga was initially admitted to Zebediela Hospital following the assault, before being urgently referred to Mankweng Tertiary Hospital for specialized care due to severe septic burns.

According to the MEC's media statement, Hlanga underwent multiple surgical procedures during her five-month stay at Mankweng Hospital, including debridement of the scalp, skin grafts, and ectroplan release.

She was officially discharged on 18 April 2025, after months of intensive care, physical recovery, and emotional resilience.

However, Hlanga was later referred back to Mankweng Hospital for further evaluation and treatment at the Eye Ward.

Hlanga's road to recovery has been long and arduous, with multiple surgeries and ongoing treatment.

She has received assessment and care for pressure garments, vital for burn recovery and scar management.

Her clinical team continues to monitor her progress closely, and additional procedures will be considered once she has sufficiently recovered.

MEC Mashego condemned gender-

based violence in all its forms and applauded the healthcare professionals at both Zebediela and Mankweng Hospitals for their tireless efforts in providing highquality care to Hlanga.

She added that the department remains committed to supporting her ongoing recovery journey and ensuring access to the necessary reconstructive and rehabilitative services.

"We call on communities to stand united against acts of violence and to support survivors on their road to healing and justice," concluded Mashego.

The alleged attacker was arrested on 14 February 2025, and appeared in court the following day.

She was granted a R3000-00 bail and the case has since been transferred to the Mokopane Regional Court.

DA calls for public support on Bill to enforce accountability in Limpopo

LIMPOPO

The Democratic Alliance (DA) in Limpopo is urging the public to support its Private Members Bill, the draft Limpopo Petitions Amendment Bill, aimed at strengthening the obligation of the Limpopo Provincial Government and its municipalities to account and be responsive to the needs of Limpopo's communities.

The party said the draft Limpopo Petitions Amendment Bill proposes to empower the Standing Committee, request updated reports where initial responses are deemed insufficient.

It is also set to hold government officials accountable to ensure that petitioners' concerns are addressed effectively by holding officials accountable for noncompliance with the Act.

According to Advocate Franco Marx, DA Limpopo Spokesperson on Standing Committee on Public Participation and Petitions, the party urges the public to participate in the initiative as the right to petition is a cornerstone of participatory democracy.



and other public authorities," he said.

Marx stressed that for impoverished, rural and socially excluded communities, it is often the only avenue in which they can engage government and seek meaningful redress or action.

"Unfortunately, this right is often undermined when members of the Limpopo Executive Council and officials fail to respect and act upon petitions," he said.

Marx emphasized that the adoption of this Bill would mark a significant step toward strengthening public participation and ensuring that the petition process serves as an effective mechanism for citizens to engage government and obtain

"The Bill has been published, and a call for representations has been issued, with copies available from the DA office or via email request," he said.

Marx furthered called on members of the public to support the Bill and exercise their right to have their say. The closing date for comments is Friday 31 October 2025.

Advocate Franco Marx, DA Limpopo Spokesperson on Standing Committee on Public Participation and Petitions, says the party urges Limpopo residents to support the Limpopo Petitions Amendment Bill, which aims to hold the government and its municipalities accountable on service delivery irregularities.

She added that Ipopeng Cultural Group's recognition on a provincial platform is a demonstration to the impact of their work in the community. "I feel very strong for my work to be recognized nationally," said Tlaka.

Mozambican national sentenced to life imprisonment for brutal crimes in Dennilton



he Groblersdal Regional Court has sentenced King Petrus Chauke to life imprisonment with an additional 17 years for heinous crimes including rape of a 13-year-old girl committed in Dennilton.

GROBLERSDAL - A Mozambican national, King Petrus Chauke (39), has been sentenced to life imprisonment with an additional 17 years at the Groblersdal Regional Court for multiple offences, including the rape of a 13-year-old girl, robbery with aggravating circumstances, kidnapping, and being an illegal immigrant.

The court delivered the sentence on Wednesday 17 September 2025, with the jury ordering that the sentences run concurrently, resulting in an effective life sentence

According to Mashudu Malabi-Dzhangi, National Prosecuting Authority (NPA) Spokesperson in Limpopo, Chauke pleaded not guilty to all charges but made admissions under Section 220 of the Criminal Procedure Act, when witnesses were to testify.

"According to the admissions, Chauke and two unknown men targeted a home in the Dennilton area on 22 September 2020, where they pointed a firearm at the complainant and demanded money and bank cards. The victims, a woman and her 13-year-old daughter, were tied up, and Chauke and one accomplice left to withdraw money while the other stayed behind to guard them. Upon returning

without funds, they assaulted and stabbed the complainant before taking the girl to nearby bushes, where Chauke raped her and abandoned her overnight," explained Malabi-Dzhangi.

She added that DNA evidence linked Chauke to the crimes, leading to his arrest and in aggravation of sentence, State Prosecutor Sifiso Miya submitted a Victim Impact Report and Pre-sentence Report, highlighting the psychological and emotional trauma suffered by the victims.

"The state argued that Chauke's selfish conduct warranted severe punishment, advocating for his permanent removal from society due to his danger to others. The court declared Chauke unfit to possess a firearm under Section 103 of the Firearms Control Act and ordered his name to be entered into the Register of Sexual Offenders," Malabi-Dzhangi said.

Director of Public Prosecutions in Limpopo, Advocate Ivy Thenga, welcomed the sentence, stating: "These cases provide justice and closure to victims and their families while removing violent criminals from our streets."

She commended the efforts of Miya and other stakeholders in securing the conviction.

Zebediela serial rapist sentenced to five life terms



William Ramoadi Minyuku was sentenced to five life terms and an additional 165 years imprisonment for terrorizing residents in the Zebediela area.

ZEBEDIELA

A 42-year-old serial rapist, William Ramoadi Minyuku, has on Friday 19 September 2025 been sentenced to five life terms and an additional 165 years imprisonment for terrorizing residents of Sehlabeng, Hlakano, and Mshongo Villages in Zebediela area.

The Limpopo High Court in Polokwane convicted Minyuku on 23 charges, including rape, housebreaking, kidnapping, and robbery with aggravating circumstances.

According to Mashudu Malabi-Dzhangi, National Prosecuting Authority (NPA) Spokesperson in Limpopo, Minyuku's reign of terror spanned six years, from March 2011 to April 2017, during which he broke into homes and attacked women and children on the streets, threatening them with a knife before raping and robbing them of their belongings.

"The court heard that Minyuku's actions had a profound impact on his victims, causing psychological, emotional, and physical trauma that left some forced to relocate to other villages due to loss of security and dignity," she said.

Malabi-Dzhangi added that despite pleading not guilty,

evidence revealed that between March 2011 and April 2017, Minyuku terrorised residents of Sehlabeng, Hlakano, and Mshongo Villages.

Malabi-Dzhangi further explained that the prosecution argued that Minyuku deliberately targeted society's most vulnerable members, and harsh sentences were the only appropriate response.

"The court ordered that the sentences run concurrently, resulting in an effective life sentence. Minyuku was also declared unfit to possess a firearm in terms of Section 103 of the Firearms Control Act 60 of 2000," she said.

Director of Public Prosecutions in Limpopo, Advocate Ivy Thenga, welcomed the court outcomes, commending State Advocate Muneiwa Ratshibvumo and Sergeant Mokgaetsi Sema of the Serial and Electronic Crime Investigation Unit for their dedication and professionalism in bringing Minyuku to justice.

"Each successful prosecution is the culmination of months and even years of painstaking investigative and prosecutorial work and reflects the many similar cases successfully prosecuted daily," said Thenga.
