On Wednesday 23 July 2025, the Limpopo Department of Public Works, Roads and Infrastructure, has embarked on an ambitious Dikgerekgere Wednesday project to improve the conditions of the D2534 Road in Ephraim Mogale Local Municipality (EPMLM).

The department's team from Tsimanyane Cost Centre undertook the task of repairing the D2534 Road, a critical route that spans a total length of 29.6 km.

The road plays a vital role in regional connectivity, linking key areas such as Marble Hall, Zebediela, Tompi Seleka Agricultural College, and the Schuinsdraai Nature Reserve.

According to the department, the improvement of the road will undoubtedly have a positive impact on the lives of residents and visitors alike.

The department's efforts are part of the Dikgerekgere Wednesday initiative, a flagship programme aimed at improving the lives of communities through infrastructure development.

# Groblersdal man arrested for R1.3 million vehicle finance fraud

#### **GROBLERSDAL**

The Hawks' Serious Commercial Crime Investigation, Hawks' Serious Corruption Investigation, and Sekhukhune Tracing Team, have arrested a 27-year-old suspect, Jason Khomotjo Rantho, at Groblersdal on Saturday 26 July 2025 in connection with fraud of a motor vehicle purchase worth over one million rand.

Warrant Officer Lethunya Mmuroa, Hawks Spokesperson in Limpopo, said the suspect is accused of assisting another individual to defraud WesBank of over R1.3 million, by using fraudulent documents to secure a motor vehicle finance application for a Ford Ranger Raptor.

"According to the investigation, the accused applied for the vehicle finance in April 2023, attaching a bank statement and employer's payslip to support the application. The application was processed and approved, and the accused collected the vehicle from a dealership in Polokwane accompanied by two men. However, the accused failed to make payments, and WesBank conducted a forensic audit that revealed the use of fraudulent

documents," explained Mmuroa.

He added that during the investigation, the Hawks' Serious Commercial Crime Investigation in Polokwane was contacted for assistance, and an investigation was conducted that led to the arrest of the first accused suspect on 2 January 2024.

"Further investigations revealed that Rantho assisted the accused in defrauding and collecting the vehicle from the dealership. He appeared in the Specialised Commercial Crimes Court sitting in Polokwane on Monday 28 July 2025, and was granted a R10 000 bail. The case was postponed to 20 August 2025," said Mmuroa.

Provincial Head of the Hawks in Limpopo Province, Major General (Adv) Gopz Govender, welcomed the arrest of the suspect and expressed confidence that the Hawks' SCCI team will crack the case.

"The Hawks are committed to investigating and bringing to justice individuals who engage in fraudulent activities. We are confident that our team will work tirelessly to ensure that justice is served in this case," she said.

# DA calls for full enquiry into failing Great North Transport

#### LIMPODO

The Democratic Alliance (DA) in Limpopo is urging the provincial government to establish a full, open, and transparent enquiry into Great North Transport (GNT) amid concerns over its financial mismanagement and dysfunction.

According to the party, the call comes as Limpopo Premier Dr Phophi Ramathuba consider another multi-million rand bailout for the struggling state-owned bus company.

According to Jacques Smalle, DA Provincial Spokesperson for Limpopo Economic Development, the Environment, and Tourism (LEDET), the party believes that all further funding to GNT should be reconsidered pending the outcome of such an enquiry and the implementation of meaningful governance reform.

"Unless the root causes of GNT's collapse are acknowledged and decisively addressed, any attempt to revive it will simply throw more good money after bad, and enable further reckless governance," he said.

GNT, which once operated 540 buses across 200 routes and transported 36 million passengers annually, has been reduced to just 23 operational buses.

Despite various turnaround attempts, including a fleet renewal plan in 2013, a formal turnaround strategy in 2017, and another turnaround drive in 2021/2022, the company remains on the brink of collapse.

Smalle indicated that the DA is concerned that efforts are being made to divert R93 million earmarked for bus procurement to cover outstanding debts

He said the Standing Committee on Public Accounts (SCOPA) report adopted by the Limpopo Legislature recently describes GNT as a "fiscal black hole" and raises serious concerns about its viability.

"The SCOPA report highlights chronic governance failures tolerated by the LEDET and the Limpopo Economic Development Agency (LEDA). The report also notes the ongoing failure of Limpopo's Executive to implement SCOPA resolutions, including repeated calls to halt funding to GNT," informed Smalle.

He said in the enquiry, the party demands a full, open,

and transparent investigation into GNT, a reconsideration of further funding to GNT pending the outcome of the enquiry and implementation of meaningful governance reform, accountability and action from Premier Ramathuba and the ANC over the collapse of GNT.

"The DA believes that further funding for GNT is futile without first cleaning out its governance and administration through a full and transparent enquiry. We are calling on the provincial government to prioritize accountability and good governance over propping up a failing public entity," concluded Smalle.

#### **EPMLM and DoHA bring services closer to the people**

## Dennilton man gets life imprisonment for raping 8-year-old minor

#### DENNILTON

The South African Division of the High Court, sitting in Polokwane, has on Friday 25 July 2025 sentenced a 45-year-old man to direct life imprisonment for raping an 8-year-old girl in Dennilton.

According to the police, the accused, who cannot be named to protect the identity of the minor, was found guilty of rape after a thorough trial.

Colonel Malesela Ledwaba, Limpopo Provincial Police Spokesperson, said the rape incident occurred on 23 December 2023, at around 11pm, when the victim was sleeping with her family members at her aunt's house in Taereng Section, Dennilton.

"The accused, who had offered the family a room to sleep, sneaked into the room and lured the child to another room where he raped her. The victim's family discovered her missing when they heard her screaming, and upon inspecting the house, they found her naked and raped in one of the

rooms," explained Ledwaba.

He said following the ordeal, the victim was taken to the hospital, and the matter was reported to the Dennilton Police Station, where it was later transferred to the Groblersdal Family Violence, Child Protection, and Sexual Offenses Unit (FCS), which investigated the case, and the accused was initially arrested on 27 December 2023.

"Although the case was withdrawn at the Moutse Magistrate's Court in Dennilton, the investigating officer continued to work diligently, and a warrant of arrest was issued after DNA results positively linked the accused to the crime. He was re-arrested at his workplace in Witbank, Mpumalanga Province," explained Ledwaba.

He said the police investigation was led by Sergeant Tsheola Lethuba of the Groblersdal FCS, who worked tirelessly to ensure that justice was served.

Ledwaba added that the court proceedings continued until 24 July 2025, when the

accused was found guilty of rape and sentenced to direct life imprisonment.

"The court also declared him unfit to possess a firearm and unfit to work with children. His details will be registered in the National Register for Sexual Offenders and Part B of the National Protectional Register," Ledwaba said.

Provincial Commissioner of the Police in Limpopo, Lieutenant General Thembi Hadebe, welcomed the court decision, stating: "The Family Violence Child Protection and Sexual Offenses Unit will continue with their good work to prevent crime and bring perpetrators thereof to justice."

# Two men arrested for murder in separate incidents

**BURGERSFORT/MARBLE HALL** 

The police in Limpopo have arrested two male suspects, aged 32 and 38, in separate incidents for murder cases that occurred in the Burgersfort and Marble Hall policing areas.

Colonel Malesela Ledwaba, Limpopo Provincial Police Spokesperson, said in the first incident, a 32-year-old man was arrested for murder in connection with the death of a man at Grootboom Farm in the Burgersfort policing area.

"The incident occurred on Saturday 26 July 2025, when the suspect and the victim were among a group of people gambling. A heated argument ensued between the two men over an alleged theft of R50, and the suspect left the scene before returning armed with a knife. He stabbed the victim in the upper body, and the victim collapsed. Witnesses at the scene apprehended the suspect and called the police," explained Ledwaba.

He added that the police arrived at the scene, and the victim was certified dead by Emergency Medical Services (EMS).

"The suspect was arrested and will appear before the Praktiseer Magistrate's Court facing charges of murder," Ledwaba said.

Furthermore, Ledwaba said in a separate incident, another suspect, a 38-year-old man, was arrested for murder at a tavern next to a taxi rank in Marble Hall Town.

"The police attended the scene of the crime in the early hours of Sunday 27 July 2025, and found the lifeless body of an unknown man lying in a pool of blood. The victim was certified dead at the scene by EMS," he said.

Ledwaba added that following the incident, the police registered a case of murder, where the suspect was successfully arrested and he will appear before the Marble Hall Periodical Magistrate's Court facing charges of murder.

"The police are committed to ensuring that perpetrators of violent crimes are brought to justice. We will continue to work tirelessly to keep our communities safe," concluded Ledwaba.
